CALL TO ORDER

Following a moment of silence requested by Dr. Lark to reflect on the recent passing of Mark Bodenhausen (AL), Dr. Douglas Butzier (IA), and John Wayne Smith (FL), Nick Sarwark called the meeting to order at 9:02 a.m.

ATTENDANCE

Attending the meeting were:

The gallery contained several attendees in addition to those listed above.

CREDENTIALS REPORT

The Secretary noted that this is the second consecutive regular meeting which Region 6 Representative Rob Oates has missed. Presuming he would not later arrive at the session, he would vacate his seat, according to Bylaws Article 8.6, which states:

"A National Committee member who fails to attend two consecutive regular sessions of the National Committee shall be deemed to have vacated his or her seat. The appointing body shall be free to reappoint the member who vacated the seat."

The Secretary reported that Mr. McMahon would not be in attendance at this session due to his participation in a medical treatment program which placed travel restrictions on him. However, staff had informed her that Mr. McMahon's sustaining membership had lapsed for a period of 10 days before he renewed it. She indicated her belief that according to the Bylaws, when Mr. McMahon's sustaining membership lapsed, he was ineligible to be an at-large member, and that this ineligibility thus created a vacancy which the LNC should fill during the meeting. She indicated she would request an agenda item for the LNC to address the question.

ADOPTION OF THE AGENDA

Starting from an implied motion to approve the chair's proposed agenda:

Mr. Redpath moved to extend and divide the one 60-minute budget agenda item so as to have a 60 minute review of the draft budget today, and then add as the first agenda item for tomorrow a 60 minute period for amendment and adoption of the agenda. The amendment was adopted by show of hands.

Since Mr. Sarwark had indicated a desire to allow for public comment immediately prior to the budget discussion, Dr. Lark moved to add an agenda item for 10 minutes of public comment just prior to today's budget review item. The motion was adopted without objection.

Mr. Hagan moved to add a 10-minute agenda item just before final announcements for a discussion of the next LNC meeting. The motion was adopted without objection.

Ms. Mattson moved to increase the time for the Electronic Meeting Rules Drafting Committee agenda item to 30 minutes. The motion was adopted without objection.

Ms. Mattson moved to add 10 minutes as the first agenda item to consider the matter noted in the credentials report, a question regarding an at-large member's status. The motion was adopted without objection.

Mr. Sarwark moved to add a 10-minute agenda item immediately after the Ballot Access Report item for discussion of creating ballot access committee. The motion was adopted without objection.

Without objection the agenda was adopted as amended, resulting in the following agenda:

CREDENTIALS QUESTION REGARDING STATUS OF AT-LARGE MEMBER

Following a discussion of the question noted during the credentials report above, Ms. Mattson moved to reappoint Evan McMahon to the at-large position. Mr. Sarwark ruled the motion to be out of order, due to his opinion that Mr. McMahon's lapse did not create a vacancy to be filled. Dr. Lark appealed the ruling of the chair.

Voting on the motion to sustain ruling of the chair was as follows:

Voting "aye": Feldman, Johnson, Kirkland, Olsen, Sarwark

Voting "no": Goldstein, Hagan, Hayes, Lark, Mattson, Redpath, Tomasso, Wiener

Abstaining: McLendon, Vohra

With a vote total of 5-8, the ruling of the chair was not sustained, allowing introduction of the motion to reappoint Evan McMahon to the at-large position.

Dr. Feldman moved a substitute motion that we affirm that Evan McMahon is an at-large member of the LNC. The motion to substitute failed by a vote of 6-7 on a show of hands.

Voting on the main motion to re-appoint Mr. McMahon was as follows:

With a vote total of 14-0, the motion was adopted.

REPORT OF POTENTIAL CONFLICTS OF INTEREST

The listing of Potential Conflicts of Interest is in Appendix A.

Ms. Mattson reported that since the previous meeting, the following potential conflicts of interest were submitted:

Daniel Hayes is the Membership Officer of the Libertarian Party of Jefferson Parish, and he is the Jefferson Parish Representative to the Libertarian Party of Louisiana State Central Committee.

Joshua Katz had since the last meeting reported that he had both formed and then closed an exploratory committee to investigate seeking the Libertarian Party's 2016 Presidential nomination.

Without objection, during the meeting other members updated their listings to remove outdated items about candidacies for November 2014 elections.

OFFICER REPORTS

CHAIR'S REPORT

Mr. Sarwark noted that he had submitted his written report (included as Appendix B) and offered to entertain questions about it.

Mr. Sarwark has received agreement to participate in the Our America Initiative lawsuit, which the LNC has previously authorized. The LNC discussed the nature of the arguments likely to be made; no action was taken.

TREASURER'S REPORT

Mr. Hagan had submitted a set of written financial reports. He and staff fielded various questions about details in the report; no action was taken.

SECRETARY'S REPORT

Ms. Mattson had submitted a written report. She has since updated the report (in Appendix C) to include the information regarding appointment of the Employment Policy & Compensation Committee and some progress on creating the missing minutes from the 6/26/14 pre-convention LNC meeting.

Since the draft convention minutes had been updated and posted on the website for the bylaws-required 14-day review period, Ms. Mattson moved to approve the June 27-29, 2014 national convention minutes.

Ms. Mattson inquired of the LNC whether they wished for the report she had earlier made to the LNC about the convention election anomalies to be included as an appendix to the convention minutes. Following discussion, Mr. Johnson moved to amend the convention minutes to add the election anomaly report as an appendix. There was no objection to this amendment.

The main motion to approve the convention minutes, as just amended, was adopted without objection.

STAFF REPORTS

A written staff report had been submitted in advance; it is included as Appendix D. Mr. Benedict presented an oral staff report. He discussed that he'd like us to develop template material for candidates, designs for yard signs, business cards, bumper stickers, etc. The ensuing discussion covered plans for how Eric Dixon's duties will be reassigned when his employment ends and how many fundraising letters should be sent annually. Since the receptionist was laid off due to budget constraints, Mr. Benedict feels they have managed reasonably well without that position, and it may not be necessary to fill it in the short term.

Dr. Lark moved that the Libertarian National Committee express its appreciation for Eric Dixon's service to the party. The motion was adopted without objection.

COUNSEL SEARCH REPORT

Mr. Sarwark noted that LNC general counsel Gary Sinawski had passed away just prior to the previous LNC meeting, and that the news of his passing did not reach the LNC until after the meeting. Mr. Sarwark has recruited a search team to write a description of our requirements for a general counsel and do the initial reviews of potential candidates to narrow it down to a short list for us. Mr. Redpath, Bill Hall (former LNC Counsel), and Mark Rutherford (Libertarian National Campaign Committee Chair) have agreed to act as that search team. Mr. Sarwark projected they could have a short list for us by the end of the first quarter of 2015.

Mr. Goldstein moved that the LNC create a general counsel search committee with 3 members to be appointed by the chair, so as to give official status to the search team just described. The motion was adopted without objection. Mr. Sarwark named Mr. Hall, Mr. Redpath, and Mr. Rutherford to the committee and designated Mr. Hall as the chair.

Mr. Sarwark mentioned that he has received inquiries from about a dozen attorneys who might be interested in becoming our general counsel, including several people who have done legal work for us in the past.

Mr. Sarwark gave updates regarding the status of current legal actions. The Kentucky litigation is in the process of shifting to a civil trial. The New Hampshire litigation is in the midst of motions to dismiss. Oliver Hall is taking over the Alabama litigation, for which Mr. Sinawski had been our lead attorney. We have not yet looked into getting a replacement for Mr. Sinawski on the Illinois litigation. Mr. Sarwark intends to sign the retainer on the Our America Initiative case on Monday.

REGIONAL REPORTS (SUPPLEMENTS)

Mr. Olsen presented an oral report to supplement his written Region 1 report in Appendix E. The Hawaii affiliate has for the first time attained ballot status with election results instead of with petitioning. The Colorado affiliate is contracted with BigL Solutions for a member management system, and the system works very well, but the affiliate is having trouble getting enough activists to make full use of its capabilities.

Ms. Kirkland presented an oral report to supplement her written Region 2 report in Appendix F.

Dr. Feldman distributed the written Region 3 report in Appendix G and supplemented with an oral report on the highlights. The Ohio affiliate continues to fight their ballot access persecution on several fronts.

Mr. Wiener presented an oral report to supplement the Region 4 written reports in Appendix H submitted by himself and Dr. Lieberman.

Dr. Lark mentioned that he had submitted a written Region 5 report prior to the meeting (included as Appendix I), and offered to entertain questions. Mr. Redpath delivered an oral report for the Virginia affiliate, which had a record number of U.S. House candidates (covering 7 of the 11 districts).

Mr. Oates had submitted the written Region 6 report in Appendix J.

Mr. Estrada distributed the written Region 7 report in Appendix K. Mr. McLendon noted that Chad Perry in Louisiana won a partisan 2-way race for Justice of the Peace.

Mr. Tomasso had submitted the written Region 8 report in Appendix L and gave an oral report on the highlights.

The LNC took no action.

BALLOT ACCESS REPORT

Mr. Redpath had previously submitted the written ballot access report in Appendix M, and he supplemented with an oral report. He noted that litigation is still ongoing in Ohio, and it is still possible for a judge to restore our ballot access there. The LNC took no action.

CREATION OF BALLOT ACCESS COMMITTEE

Mr. Sarwark indicated he would like to have five to seven people on a working committee to backstop the work of Mr. Redpath and Richard Winger; no draft language was presented for adoption. Mr. Olsen noted that this committee needs to assemble a wiki and/or database of data from past ballot access drives; there was broad agreement on this point. Mr. Goldstein requested that such a committee take on tasks such as setting parameters for obtaining LNC funding, managing the drives, etc. Mr. Redpath supports creation of the committee, but cautioned against it prohibiting quick emergency decisions that inevitably happen. The LNC took no action.

The meeting adjourned for a 90-minute working lunch at 12:38 p.m. During lunch the LNC discussed our website design, what changes might be desired, etc.

The meeting was called back to order at 2:10 p.m.

REPORTS OF STANDING COMMITTEES

AFFILIATE SUPPORT COMMITTEE

Affiliate Support Committee Chair Guy McLendon delivered an oral report to supplement the written report in Appendix N. The LNC took no action.

APPOINTMENT OF THE AUDIT COMMITTEE

Following a review of the relevant bylaw and board policies, nominations were opened for the Audit Committee, for which the LNC is to appoint one non-officer LNC member and two non-LNC members.

Mr. McLendon nominated Gary Johnson (TX).

Ms. Kirkland nominated Aaron Starr (CA).

Mr. Olsen nominated George "Bud" Martin (CO).

Mr. Wiener nominated M Carling (WA).

Nominations were closed without objection, and nominators spoke on behalf of the nominees. Without objection Gary Johnson was selected for the non-officer LNC member position.

For the remaining two non-LNC positions, ballots were cast by the non-officers using approval voting, with Mr. Spencer and Dr. Lieberman serving as tellers.

With 11 ballots cast, the vote totals were as follows: Aaron Starr – 10 M Carling – 9 George Martin – 2

Additionally, there was one illegal vote cast for Gary Johnson, who was not eligible to serve in the non-LNC positions and had already been elected to the one non-officer LNC member position.

With a majority of the number of ballots cast, Aaron Starr and M Carling were elected to the 2 non-LNC member seats on the Audit Committee.

(Post-adjournment note: The Audit Committee members subsequently chose Aaron Starr to be the committee chair.)

AWARDS COMMITTEE

The Awards Committee is not presently populated. There was general agreement that the LNC would appoint this committee at next LNC meeting. The LNC took no action.

APPOINTMENT OF THE CONVENTION OVERSIGHT COMMITTEE

Following a review of the relevant policies, nominations were opened for the 4 LNC members or alternates to be elected by the LNC to Convention Oversight Committee positions. The committee also has three positions for non-LNC members that will be appointed by the LNC Chair at a later date.

Mr. Goldstein nominated Vicki Kirkland.

Mr. McLendon nominated Daniel Hayes.

Ms. Mattson nominated herself.

Mr. Vohra nominated himself.

Mr. Marsh nominated himself.

Mr. Hayes nominated Jay Estrada.

Nominations were closed without objection.

Ballots were cast using approval voting, with Mr. Spencer and Dr. Lieberman serving as tellers.

With 14 ballots cast, the vote totals were as follows:

Mattson – 12

Hayes – 11

Kirkland - 11

Estrada – 9

Marsh - 7

Vohra - 6

With a majority of the number of ballots cast, Alicia Mattson, Daniel Hayes, Vicki Kirkland, and Jay Estrada were elected to the Convention Oversight Committee.

EMPLOYMENT POLICY & COMPENSATION COMMITTEE (EPCC)

EPCC Chair Dr. Lark had submitted the written report in Appendix O and fielded questions, noting that the modifications made last term to the employee manual should be reviewed by an attorney experienced in Virginia employment law, and that work should be done this term to further develop whistleblower and document retention policies, subject to LNC review. The LNC took no action.

IT COMMITTEE

On behalf of the IT Committee, Sam Goldstein delivered an oral report to supplement the written report in Appendix P and fielded questions. The LNC took no action.

REPORTS OF SPECIAL COMMITTEES

ELECTRONIC MEETING RULES DRAFTING COMMITTEE

The committee appointed during the September 2014 LNC meeting to draft rules for electronic meetings submitted the written report in Appendix Q.

On behalf of the committee, Ms. Mattson discussed with the LNC the nuances of the rules being proposed by the committee. The report notes the expected cost of the Adobe Connect system, but in addition a toll-free dial-in system is required to allow for telephone-only connections. The committee was still researching costs for that at the time the report was submitted, but Ms. Mattson has found a service provider from whom we can obtain a toll-free number with a cost of 2.5 cents/minute with no contracts, minimum monthly charges, or monthly fees.

Discussion of the rules with the LNC revealed a desire for a few modifications; to allow the committee time to draft the changes, Ms. Mattson moved to postpone the agenda item (with 15 minutes of allotted time) until tomorrow after the final item of new business without previous notice. The motion was adopted without objection.

DISCUSSION OF 2015 BUDGET

Following public comments regarding the budget, Mr. Hagan presented the draft budget and fielded questions about it.

At approximately 5:00 p.m. Mr. Hayes moved to enter executive session for the purpose of discussing employee compensation in the budget. The motion was adopted without objection.

The LNC rose from executive session at 6:20 p.m. and immediately adjourned without objection.

The meeting was called to order on December 14, 2014 at 9:04 a.m.

Ms. Mattson moved to amend the agenda to add as the last item of new business without previous notice a 15-minute item to discuss an apparent convention policy violation that she found while assembling the convention data archive. The motion was adopted without objection.

Ms. Mattson moved to enter executive session to provide information that was missing during yesterday's executive session discussion. The motion was adopted without objection, and the LNC entered executive session at 9:06 a.m. for purposes of discussing employee compensation. The LNC rose from executive session at 9:40 a.m.

ADOPTION OF 2015 BUDGET

Starting from an implied motion to adopt the draft 2015 budget:

Mr. Redpath moved to amend budget Ballot Access Petitioning Related Expense (line 70) to increase it from \$50,000 to \$57,500. Following debate, the amendment was adopted by a show of hands.

Following discussion, Ms. Mattson moved to amend the budget to add a proviso that, "Ballot access expenditures for 2015 shall only be authorized by a two-thirds vote of the Executive Committee and the total expended cannot exceed the budgeted amount." Following debate, the amendment was adopted by a show of hands.

Mr. Goldstein moved to amend Compensation (line 45) to reduce it from \$511,300 to \$475,700. The motion was adopted without objection.

Mr. Johnson moved to amend Member Communication Expense (line 85) to allow for 6 issues of *LP News* rather than 4, which would require a \$17,200 increase from \$34,400 to \$51,600.

Mr. Vohra moved to amend the Johnson amendment to instead be a \$3,600 increase from \$34,400 to \$38,000 to keep the current plan of 4 print editions but add 3 electronic editions of *LP News*.

Following debate, the Vohra amendment to the Johnson amendment failed by a show of hands. A vote on the Johnson amendment failed by a show of hands.

Since the spending requests from the IT Committee and the Affiliate Support Committee were not accompanied by detailed spending plans, and the budget may be amended later when details are available, Ms. Mattson moved to amend as follows:

- Reduce the IT portion of Capital Expenditures by \$10,000;
- Reduce the IT expense portion of Administrative Costs (line 40) by \$5,000; and
- Reduce Affiliate Support (line 50) by \$10,000.

The net effect of this amendment would leave \$5,000 each for IT capital expenditures, IT administrative expense, and affiliate support.

Mr. McLendon moved to divide the question so as to consider 2 motions, one for the IT reductions and one for the affiliate support reductions. The motion to divide was adopted by a show of hands.

First the LNC took up the motion to reduce IT funding (capital expenditures by \$10,000 and administrative costs by \$5,000).

Mr. Goldstein moved to substitute for the Mattson amendment a proviso that, "No spending related to IT initiatives shall take place without a plan approved by the LNC." The vote to substitute a proviso for the Mattson motion passed, so the Goldstein motion to add the proviso became the primary amendment.

The primary amendment to add a proviso that "No spending related to IT initiatives shall take place without a plan approved by the LNC" failed by a show of hands.

The LNC took up the second half of the previously divided question, the Mattson motion to reduce Affiliate Support (line 50) by \$10,000. Mr. Goldstein moved to amend the Mattson amendment so that instead of the specified reductions it would be addition of a proviso that "No spending related to affiliate support initiatives shall take place without a plan approved by the LNC." There was no objection to the Goldstein amendment, making that proviso the primary amendment.

The primary amendment to add a proviso that "No spending related to affiliate support initiatives shall take place without a plan approved by the LNC" failed by a show of hands.

Since 6 house fundraising letters were sent this year, Mr. Johnson moved to amend the budget to allow 3 more house fundraising letters in 2015 for a total of 9 by increasing Donations (line 21) by \$60,000 and increasing Fundraising Costs (line 32) by \$33,000.

Mr. Bittner moved to amend the Johnson motion to instead increase Donations (line 21) only by \$40,000 and increase Fundraising Costs (line 32) by \$33,000.

The Bittner amendment to the Johnson amendment passed on a show of hands, making it the primary amendment. The Bittner motion as the primary amendment was adopted by a show of hands. Note that the Bittner amendment necessitated another \$1,080 increase in line 32, for increased credit card processing fees as a result of the anticipated increase in donations.

Voting on the main motion to adopt the 2015 budget as amended was as follows:

<u>Voting "aye":</u> Bittner, Goldstein, Hagan, Hayes, Johnson, Kirkland, Lark, McLendon, Olsen, Redpath, Sarwark, Tomasso, Vohra, Wiener

Voting "no": Mattson

With a vote total of 14-1, the motion was adopted, resulting in the 2015 budget shown below.

As shown in the minutes below, later in the meeting Litigation (line 75) was further amended to increase it by another \$7,500. That change is incorporated in the table below, though it happened later in the meeting.

BUDGET PROVISO: Ballot access expenditures for 2015 shall only be authorized by a two-thirds vote of the Executive Committee and the total expended cannot exceed the budgeted amount.

Ms. Mattson moved that the LNC refer to the Employment Policy & Compensation Committee the task of researching past employee contract structures and making recommendations for going forward. The motion was adopted without objection.

NEW BUSINESS WITH PREVIOUS NOTICE

CONVENTION OVERSIGHT COMMITTEE MAINTAIN CONVENTION ARCHIVE

Ms. Mattson moved to amend the Policy Manual as follows:

1.03.2 Committee Terms of Office

With the exception of the Convention Oversight Committee, The terms of office of all project managers, committee chairs, and committee members shall expire with the administration that appoints them, or when their successors are chosen, whichever occurs first. The term of office for the Convention Oversight Committee shall expire 90 days following the close of the convention.

2.02.5 Convention Oversight Committee

The Convention Oversight Committee shall make recommendations for convention sites to the LNC, but the LNC shall choose the site. On other matters concerning the Party's conventions, the committee shall act on behalf of the LNC, including:

- conveying requirements to convention planners.
- ensuring the convention meets the Party's needs.
- reviewing and approving in a timely manner major elements, such as contracts, the convention budget and the convention program.

The committee shall periodically report its decisions and actions to the LNC. The committee may begin its work as soon as its members from the LNC are appointed.

<u>During the 90 days following a convention, the committee shall make a final report to the LNC of actual versus expected convention performance, and the committee shall update the online convention archive with information comparable to what the archive contains for past conventions.</u>

Following debate, the motion was adopted without objection.

MODIFY AWARDS COMMITTEE STRUCTURE AND APPOINTMENT

Ms. Mattson moved to amend the policy manual as follows:

1.03.1 Committee Appointments

These committees have special appointment procedures as follows:

In the absence of this rule, the term of office of a special committee would expire when the assigned task is completed and the committee reported back to the assembly (see RONR p. 492 lines 3-7), except that in a board the special committee would expire with the body that appointed it (see RONR p. 502 lines 31-35).

In the absence of this rule, the committee could not begin its work until all of its members were named (see RONR p. 496 lines 8-11).

Ms. Mattson inquired whether there would be any objection to amending the final two paragraphs of Policy Manual Section 2.02.4 (Awards Committee) as follows:

With a majority vote the committee may select recipients of the Thomas Jefferson, Samuel Adams, Thomas Paine, and Patrick Henry awards. While the committee has discretion as to the frequency of such convention awards, it is <a href="https://hoped.ncbi.nlm

With a unanimous vote the committee may select recipients of the Hall of Liberty award, with up to 3 inductees per convention. While the committee has discretion as to the frequency of this convention award, it is <a href="https://hoped.ncbi.nlm.

There was no objection.

CONSTRUCTIVE CANDIDATE PORTRAYAL

Ms. Mattson moved to add a new section to the policy manual as follows:

2.06.6 Constructive Candidate Portrayal

In public communications of the Party, Libertarian candidates shall be portrayed as seeking to implement public policy by their election to public office. They shall not be portrayed as spoilers, either directly or by implication, such as noting that the candidate's performance spans the margin between two other candidates.

Following debate, the vote on the main motion was as follows:

Voting "ave": Mattson, Redpath, Tomasso

<u>Voting "no":</u> Bittner, Goldstein, Hagan, Hayes, Johnson, Kirkland, Lark, McLendon, Olsen, Sarwark, Vohra, Wiener

With a vote total of 3-12, the motion failed.

NEW BUSINESS WITHOUT PREVIOUS NOTICE

BRANDING/LP LOGO REDESIGN

Mr. Bittner led a discussion regarding potentially changing our logo. He suggested we had 5 basic options for proceeding:

Crowd-source a design using a site like www.99Designs.com

Go to a graphic designer with an idea of what we want and ask for options
Use our DesignForLiberty group, some of whom have proposed logos they'd like to submit
We have people who have done graphic work on spec just for the opportunity to be considered
No action

Mr. Goldstein noted that if we're going to change our logo, the IT committee should work that into any website redesign efforts they might undertake. The LNC generally discussed opinions of our current logo, known alternatives, potential processes for making a decision, the cost impact on state affiliates who have based their state logos on the national logo, etc.

Mr. Goldstein moved that the Chair appoint a committee of 3 LNC members or alternates to solicit new logo designs and report back to the LNC no later than 3/1/2015. Following debate, the motion was adopted without objection.

(Post-adjournment note: On 12/18/14, Mr. Sarwark announced that he had appointed Brett Bittner, Norm Olsen, and Arvin Vohra to the Logo Committee.)

RENEWING FEC LITIGATION

Mr. Sarwark spoke about the possibility of renewing FEC litigation about the impact of contribution limits on bequests. We previously sued over this subject in the D.C. District Court, but by the time it got to court we had used up most of that bequest, and the court dismissed the case as being moot and said it wasn't likely to happen again. Now we have another bequest that will take several years to collect due to the contribution limits.

Alan Gura has offered to handle the suit for us for \$5,000 per year plus actual costs such as filing fees and travel, so we should expect to spend about \$7500 per year while the case would be ongoing.

Mr. Sarwark moved (as amended without objection) that the LNC authorize Alan Gura to reopen litigation on the subject of contribution limits on bequests and to amend the budget to increase the line 75, Litigation, by \$7,500.

Following debate, the vote on the main motion was as follows:

<u>Voting "aye":</u> Bittner, Goldstein, Hagan, Hayes, Johnson, Kirkland, Lark, Mattson, McLendon, Redpath, Sarwark, Tomasso, Vohra, Wiener

Voting "no": Olsen

With a vote total of 14-1, the motion was adopted.

CHANGE AFFILIATE SUPPORT COMMITTEE REPORT DUE DATE

Mr. Tomasso moved to amend the shown portion of Policy Manual Section 2.02.2 (Affiliate Support Committee) as follows:

"The ASC shall deliver a report to the LNC on November 10th of each year, for the last LNC meeting of each calendar year identifying and prioritizing those needs and interests of the various affiliates."

The motion was adopted without objection.

ELECTRONIC MEETING RULES

On behalf of committee Ms. Mattson moved (as amended without objection to change an "and" to an "or") to amend the existing Policy Manual Section 1.02.6 as shown and to insert a new section 1.02.7 as follows:

1.02 Meetings

6) Meeting Minutes

[snip]

Meeting minutes for face-to-face <u>or electronic</u> LNC meetings may be promoted from draft status to official during the time between LNC meetings as follows: [snip]

7) Electronic Meetings

- a) The term "electronic meeting" within these electronic meeting rules shall be construed to include teleconferences and videoconferences.
- b) The term "committee" within these electronic meeting rules shall be construed to include both the LNC (as the board of the Libertarian Party) as well as committees.
- All videoconferences will be conducted via the Adobe Connect (Citrix) service, hereinafter referred to as Adobe Connect.
- d) Electronic meetings may be called by either:
 - The committee Chair, or
 - 1/3 of the committee members or 2 committee members, whichever is greater. However, the call of an electronic meeting can be canceled if a majority of the committee members email a cancellation request to the entire committee prior to the scheduled time of the meeting.
- e) Each committee member calling for an electronic meeting must do so by emailing the entire committee and specifying the date of the meeting, time of the meeting, and the topic(s) to be addressed. Meetings must be so called no fewer than 2 days in advance for committees with fewer than 10 members, or 7 days in advance for committees with 10 or more members. These time limits do not apply to the LNC's Executive Committee, the LNC's Advertising and Publications Review Committee, or the Judicial Committee.
- f) For electronic LNC meetings, messages calling or vetoing a meeting must be sent on the LNC-Business email list.
- g) When a sufficient number of people have issued a call for an electronic meeting, the committee Chair or Secretary shall issue a notice of the meeting to each member and alternate of the committee. In addition to the standard notice content, the meeting notice shall describe how to participate in the meeting.
- h) Each participant must provide his own equipment and connectivity, including but not limited to any computer, internet access, web camera, microphone, earphones, or telephone. Members and alternates have the right to participate in an electronic meeting by telephone, however they should use a computer connection if feasible so as to be able to more fully use the Adobe Connect features. The organization is not responsible for providing a central location for physical attendance of an electronic meeting. For face-to-face meetings, electronic participation is not allowed.
- i) Each participant must accurately identify himself by name when joining the meeting. Videoconference participants other than members or alternates of the committee must precede their sign-in name with "zz" so as to group them at the end of the alphabetical participant list.

- j) <u>Electronic meeting participants must try to eliminate, as much as possible, background noise, echoes, and call waiting interruptions. Participants shall not place their telephone connection on hold if the system has music or messages playing while in that mode.</u>
- k) All participants legally consent to having the meetings recorded, should the committee opt to do so.
- l) <u>Electronic meetings are special meetings such that only the topics listed in the call of the meeting may be considered during the meeting.</u>
- m) For original main motions, the committee Chair or Secretary shall document the time at which the vote tally was announced. A person eligible to vote who was present during the debate of the motion but who lost his connection to the meeting may still reconnect to the meeting and cast his vote on the motion no more than 5 minutes after the announcement of the vote tally.
- n) If the committee permits, participants other than members or alternates of the committee may observe videoconferences using Adobe Connect (and not by a toll-free number) with their web cameras off and their microphones muted.
- o) The LNC Secretary shall promulgate these rules to all members/alternates of each committee upon notice of their election or appointment.

Following debate, the motion was adopted without objection.

CONVENTION POLICY

Ms. Mattson reported that while she was assembling materials for the convention archive, she noticed what appeared to be a violation of an LNC convention policy for the 2014 convention, specifically the portion of Policy Manual Section 2.03.4 which states that, "The Party shall not directly or indirectly compensate or otherwise underwrite or subsidize the convention travel, lodging (excepting room upgrades which the Party received at no cost), entertainment costs or speaker fees/honorariums of any Convention delegates." Both Geoff and Nancy Neale were credentialed as convention delegates, yet the Party's invoice from the hotel included a \$699.15 charge for their hotel room. Mr. Hagan had contacted Mr. Neale about it, and Mr. Neale indicated that if we asked him to reimburse us for the room, he would stop his \$100 monthly pledges for 7 months to offset his cost.

Following general discussion, Ms. Mattson moved that we request Geoff Neale to reimburse the party \$699.15 for his convention hotel room. The motion failed for lack of a second.

DISCUSS NEXT MEETING LOCATION

Mr. Goldstein moved that the next LNC meeting be in Phoenix on March 28-29, 2015. The motion was adopted without objection.

ADJOURNMENT

Following announcements and public comment, the LNC adjourned without objection at 1:10 p.m.

Secretary's Report

For December 13-14, 2014 LNC Meeting

Following is a status report for minutes of LNC and EC meetings since the previous LNC meeting:

- September 20-21, 2014 LNC session auto-approved on October 22, 2014
- September 23, 2014 Executive Committee teleconference auto-approved October 8, 2014
- October 24, 2014 Executive Committee teleconference auto-approved on November 7, 2014

The needed updates have been made to the draft convention minutes the LNC previously received. The new draft is posted on the website, and by the time of the meeting they will have been posted for the bylaws-required 14 days. I intend to make a motion to approve them during the LNC meeting on December 13.

I have twice requested but not yet received a draft of the 6/26/14 pre-convention LNC meeting minutes in Columbus. During the week before this meeting, I reviewed an audio recording of the 6/26/14 meeting to create the core content of the minutes. Once the final edits are done and the appendices are attached, we can approve them by an email ballot.

I have finished assembling the convention data archive material that I was able to find for the 2008, 2010, and 2012 conventions. I have loaded those materials into our internal wiki so that future convention planners can readily access it. I think I've organized it in a user-friendly way so a person can readily find what they're looking for.

The Policy Manual has been updated to reflect the 5 changes made in the September 20, 2014 LNC meeting.

I have worked with 5 others on the committee to develop rules for electronic meetings. We evaluated a dozen different host software options and will be proposing a set of rules in a separate report.

The Chair announced by email on November 15, 2014 that he was appointing Brett Bittner, Jim Lark, and Joshua Katz to the Employment Policy & Compensation Committee. The committee subsequently met and elected Jim Lark to be the committee chair.



Executive Director's Report

Overview

In 2014, we spent a lot of time and money on internally focused projects, like buying a building, changing our membership plan, increasing LP News from 4 to 6 issues per year, and setting up wikis (all LNC mandated projects for staff). Nevertheless, the LP fielded a large slate of candidates nationwide and had positive election results, plus we squeezed in some externally focused projects, like LPStore.org (with new products).


What I'd like to see in 2015:

- Provide candidate campaign material templates for signs, brochures, stickers, websites & more (to support the LNC's goal of 1,000 candidates and 200 elected officials in 2016) along the lines of what the Libertarian Booster PAC offered to Texas candidates in 2012, and Virginia candidates in 2013.
- Roll out new features in Raiser's Edge, rather than start over with a new software vendor.
- Clean up the current LP.org website, rather than rebuild from scratch.

Nevertheless, I'm expecting the LNC will probably decide to build a new website from scratch. And, despite my reservations, I can see many advantages of starting over with a fresh look, less clutter, and using a simpler content manager like Wordpress. I'm hoping a new website will cost in the \$10,000 range rather than the \$50,000 range. I have a hunch that the more expensive the website, the more complex it is, and the harder it is for staff to use it effectively.

Comprehensive membership and financial reports are submitted separately from this report.

David F. Nolan Memorial Building Headquarters



Overall, the move to the new purchased office has gone well and is already saving money. I'm pleased about the move



and I think it was the right decision. However, I don't want to

ignore the time and cost, not only of making the move, but also the cost of raising the money and honoring our donors. Below is a table of promises made to our donors. We're still working to finish fulfilling some of the promises. For example, we've ordered most of the plaques, such as the one shown above, and have samples of the certificates underway, but we still have to finish printing and shipping the certificates.

\$25,000 or more — Nolan Liberty Room

Donors at this level will be honored by being named a sponsor of one of **just five rooms open for dedication in your name** (or the name of a loved one) at the David F. Nolan Memorial Office.

\$10,000 or more — Nolan Founder

\$5,000 or more — Nolan Hero of Liberty

Donors at this level will be one of the 50 names memorialized on the special **Nolan Hero of Liberty Plaque** that will be permanently displayed in the new office above the Benefactor plaque below.

\$1,000 or more — Nolan Benefactor of Liberty

Donors will be recognized with one of the 200 names inscribed on the special **Nolan Benefactor of Liberty Plaque** that will be permanently displayed in the new office.

\$500 or more — Nolan Defender of Liberty

Donors at this level will have appear forever in the leather-bound **Nolan Defenders of Liberty Registry** that will be placed in the foyer of the Nolan office. (No limit.)

\$250 or more — Nolan Friend of Liberty

Donors at this level will be inscribed on a **Nolan Friend of Liberty** framed certificate that you'll be proud to hang in your home. (No limit.)

\$100 or more — Nolan Advocate of Liberty

The donors at this level will be recognized by name in LP News as a **Nolan Advocate of Liberty**, and your name will appear in a special section of the LP website dedicated to Nolan office contributors. (No limit.)

New membership levels implementation plan

In 2011, a committee of the LNC designed a new membership plan, then postponed implementation to be concurrent with the move to the new building. Announcement of new plan brought in a significant number of new Lifetime members who beat the August 1, 2014 deadline (after that, the cost of a life membership increased from \$1,000 to \$1,500). 
While no longer under contract, we cooperate with a merchandise vendor, LPStuff.com, by providing a link to their company website. In return, LPStuff.com offers a wide variety of Libertarian branded products, from stickers to brochures to apparel. However, LPStuff.com is an independent company, and the LNC receives no profits from the sale of items at LPStuff.com, nor does it have control over the offerings. We also don't receive the contact information for people who make purchases at LPStuff.com, and we don't receive information on the quantity of items sold. For those reasons, and in response to a shortage of particular offerings, especially current brochures, we set up an LNC-controlled site, LPStore.org. Our goal isn't to put LPStuff.com out of business. I don't foresee the LNC trying to offer the broad range of products LPStuff.com offers. I expect to offer links to both stores from LP.org for the foreseeable future. Also, there are many advantages to being able to combine our fundraising email efforts with special promotions offered at our own store.



Fundraising Letters

In 2014, we cut back from the usual ten planned house fundraising letters to seven, partly due to complaints about the number of letters sent, and to see if revenue per letter would increase. (House letters are fundraising letters sent to our primary list of recent donors, as opposed to membership renewal letters, or prospecting letters which are sent to people who haven't donated before.) Different house letters are sent to different quantities of people, so direct comparisons should be done with care. For example "1405 HO building fund" was only sent to previous donors to the building fund, a small portion of our house list, with a similarly small overall cost. If you save copies of your fundraising letters, you can probably figure out which letter goes with which bar on the chart below, and it may be interesting to see how various letters performed financially. We do sometimes change writers and signers of the letters. I'm leaning towards sending seven house letters again in 2015 due to complaints and expected budget constraints, although most direct mail experts would recommend sending at least one per month. I recommend the LNC discuss the issue of fundraising letter frequency further.

The "1303 Building Fund" was the highest performing letter in several years. Urgent Gram-style letters have performed well overall in 2014, but also generated complaints. Perhaps counter-intuitively, the more positive sounding letters, "1310 HO Heroes" and "1311 HO Invest in growth," generated almost no complaints, but also small profits.



Board Report

The following chart, which we refer to as the "Board Report," has more details on fundraising. Beware, this is a manually updated chart, not all areas are complete or tracked, and the cost information can be particularly misleading due to which costs may or may not be included, and how costs are allocated. Additionally, the numbers change as new donations arrive. Nevertheless, incomplete data is presented and is hopefully more informative than withholding the data available.

In 2011 we used paid advertising that targeted our facebook fans to become members, and the ads actually made a profit (a rarity in prospect advertising). Eric Dixon restarted paid ads in October and we've recruited 201 members, raising \$5,025 at a cost below that. While it would seem logical to ramp up the spending on something that is either profitable or slightly unprofitable for membership recruitment, unfortunately, tests of increasing the spending rate on the ads has not linearly increased the funds raised. We plan to continue facebook ads in 2015.

Staff Personnel Changes

The Member Services Specialist position remains unfilled. We've not attempted to fill that position due to financial constraints and possible 2015 staff budget cuts. Eric Dixon, Editor and Technology Developer, leaves us December 4, 2014. We started a replacement search for Eric. Eric was highly skilled, and it's unlikely we'll be able to find and hire someone with all of his skills. We will likely assign some his duties to other existing staff, hire an additional staff person, and assign other duties to contractors.

LNC Political Director Report Sep. 6 - Nov. 26, 2014

Key observations of Election 2014

2014 was a very positive growth year for the LP based on media coverage, inclusion of our candidates in polls, voter registration, and votes.

While the media remains strongly biased in favor of Democrats and Republicans, media coverage of Libertarians and the LP improved substantially this election.

Owing to a number of races that potentially could swing the balance of power in the Senate, as well as some tight races for governor, several of our candidates were featured in national media, including on Fox News, New York Times, Washington Post, CNN, NPR, LA Times, Associated Press, Wall Street Journal, Newsmax, MSNBC Hardball, Breitbart, Huffington Post, ABC News, USA Today, Daily Caller, the Stossel Show (post election) and Time magazine. Three candidates were interviewed on Fox Business News' *The Independents*, and Reason ran several positive stories and columns on the LP and our candidates. The Independent Institute's *The Beacon* covered the Wyllie campaign.

Candidates who received notable national coverage included Sean Haugh for US Senate in North Carolina, Amanda Swafford for US Senate in Georgia, Adrian Wyllie for governor in Florida, David Patterson for US Senate in Kentucky, Andrew Hunt for governor in Georgia, Chad Grimm for governor in Illinois, Rob Sarvis for US Senate in Virginia, Doug Butzier for US Senate in Iowa (Rest In Peace), and Lucas Overby for US House in Florida.

A number of candidates received substantial coverage within their states, including Adrian Wyllie, John Buckley for US Senate in West Virgina, Rob Sarvis, Keen Umbehr for governor in Kansas, Steve French for governor in South Carolina, Jack Seaman for US Senate in North Dakota, and Frank Gilbert for governor of Arkansas.

Collectively the national coverage we received for these races rivaled that of several of our past presidential campaigns. The LP would need to spend millions of dollars in advertising to match the free coverage the LP got for these races, suggesting that we should relish the opportunity to run candidates in tight races.

Similarly many more Libertarians were included in publicized polls, mostly in these same close races. Many of them polled in high single digits and a few in low double digits –possibly more than the LP has ever seen. While vote totals came down from poll numbers in the end, as is typical, they remained strong considering the record-shattering levels of spending by Democrats, Republicans and their respective PACs this election year.

The LP also broke a record for top-of-ticket votes in a midterm election year, despite the fact that we did not have top-of-ticket candidates in California or Washington owing to "top two" and despite the fact that voter turnout was low nationwide.

Exit polls showed that our candidates are continuing to pull disproportionately high vote percentages from young voters. Given that young voters are more inclined to skip midterm elections than older voters, this, along with the above 2014 results, are all signs that the LP's presence on the ballot is having an increasing impact on elections and that we are well-positioned to do even better in 2016.

At the same time, we continue to face difficult ballot challenges. This was most notable in Ohio where the governor and AG candidates were thrown off the ballot and in New York where our governor candidate was placed in a hard-to-find position on many ballots. Our state senate candidate Gigi Bowman faced a nasty challenge to her petition signatures from the incumbent. This resulted in her being described as "not on the general election ballot" in some key news coverage. Several precincts used ballots that omitted her name, despite her being legally qualified for the ballot.

Jeremy Walter's race for state house in South Carolina was disappointing but not surprising. He won just under 20% of the vote against the same Republican whom he almost beat in 2012 with 47%. The difference this year was that the Republican was the incumbent and also that she was on the ballot as a Republican – whereas she had to run as an independent in 2012. This is a reminder that D/R partisan voting remains a significant barrier for alternative parties.

More good news: Libertarian voter registration is up over the last seven months by a higher percentage than the increase of all other parties and independents combined. This follows a 16-month period where Libertarian registrations were the only ones to go up while all other party registrations went down.

Seventeen Libertarians were elected to local offices in November, including seven who were unopposed. Another advanced to a runoff election in December.

Director of Operation's Report

Blackbaud – Data Dumps – Internal Customer Service

We continue to do various ongoing clean ups of emails and other items in the dumps including a recent National Change of Address on 90k plus records resulting in almost 8k forwardable moves. The new membership levels have been included in dumps since Sept with no issues from states. As a result of the ASC survey, staff reached out to several states that had reported data issues and concerns. All but one of those have decided on taking the simpler updated 2012 formatted data dump and they appear to be happy with the results. We urge all states that currently receive the old formatted dump to contact us regarding the updated format which is much easier for states to use.

Building Fund

We've raised \$2765 since 09/01/14 thru 11/25/14. The final individual donor room and perpetual plaques have been ordered and recognition certificates will be going out early next month.

FEC Filing

We continue to file accurate FEC reports and use Paula Edwards to complete the FEC Filing Process on a monthly basis and handle our amendments. The reconciliation and audit steps to this process continue to work to assure that these reports are correct prior to filing, and to insure that the disbursements and contributions match to our cash accounting records.

As a reminder, the FEC reports are done on a cash basis while our financial reports are done on an accrual basis as required by our bylaws which require adherence to GAAP. Therefore, our Statement of Operations will not always look the same as what is reported on the summary page of our FEC Filings.

Financial

Finances remain very tight despite some improvement in fund raising for Sept & Oct. however Nov was one of our worst months ever in part due to slow mailing of the current house letter. Results should improve in Dec.

As of 11/25 we have \$19k in unrestricted funds available with some large expenses coming up including our annual software fee for Raiser's Edge (\$12k) and ½ yearly payment of property taxes (\$4.4k).

We currently have zero a/p and as the treasurer previously reported the Hyatt bill was paid in full early in Oct.

Staff also has spent countless hours working with the treasurer and the E/C on the budget thru multiple drafts. A very conservative approach is urged as funds will remain tight throughout

2015. Staff looks forward to working with various committees (ASC / IT) to come up with some cost effective solutions.


How do close races affect Libertarian percentages?


It's often speculated that Libertarians get lower percentages in races where the election appears to be close between the Republican and Democrat, presumably because people might not want to "waste their vote" on a Libertarian when the race is close. However, 2014 data for races for U.S. Senate and Governor show the closer the race was between the Republican and Democrat, the *higher* the vote for the Libertarian (though the correlation is minor and highly variable). Perhaps close races have a lot more negative ads about the major party contenders which may depress the Democrat and Republican votes. Additionally, speculation about how Libertarians might affect the outcome of close races may increase visibility of the Libertarian, which may increase the Libertarian vote.

Libertarian National Committee Region I Report

Overview

- The nine affiliates which comprise Region 1 are: Alaska, Arizona, Colorado, Hawaii, Kansas, Montana, Utah, Washington, and Wyoming.
- For all the usual reasons related to the demands of election activities and the subsequent holidays, this report is very brief. Most all pertinent information pertains to the election results which are reported in detail in other LP reports.
- Aggressive election activity has produced continued ballot access for the 2016 general election in eight (AK, AZ, CO, HI, KS, MT, UT, WY) of the nine states in the region are currently ballot qualified for 2016.
- Ballot access in Washington State requires 1,000 valid signatures; a rather reasonable threshold compared to many other states. Over the years, the Washington State affiliate has routinely obtained ballot access without assistance from the national committee.
- While they have not survived challenges which kept them off the 2014 ballot; Top Two type legislative activity remain alive and well in Arizona and Montana. It is quite likely that these measures will resurrect themselves in future legislative sessions in these states. Republicans will likely be proposing measures of this sort again. We need to be prepared.
- Significant increases in voters registering as Libertarian have been experienced in several of the states in the Region. This trend of several years remains strong in the region.
- Due to the geographic nature of this region, which spans five time zones and extends from 19 to 71 degrees north latitude (some 3,000 x 3,000 miles), personal contact between the Regional and Alternate Representatives and the individual affiliates is quite rare.

The Alaska Libertarian Party won a consolation prize. From the Alaska Dispatch News of December 9, 2014:

Alaska Libertarian Party gubernatorial candidate Carolyn Clift came in a distant third place in last month's election -- but she still won her party a consolation prize.

Clift's result means the Libertarians will get a pair of seats on the Alaska Public Offices Commission, the state board charged with regulating elections and lobbying laws.

That's because four of the five commissioners are split up between the two political parties whose gubernatorial candidates earned the highest vote totals in the most recent election. The fifth commissioner is nominated by the other four, with final approval coming from the governor.

Clift placed third, but the winning candidate, Bill Walker, ran as an independent with the endorsement of the Alaska Democratic Party, whose own gubernatorial candidate, Byron Mallott, dropped out of the race to become Walker's running mate.

That means that APOC members will come from the Alaska Republican Party, whose candidate, Sean Parnell, placed second, and from the Libertarian Party.

The shift was first reported by political blogger Amanda Coyne.

Michael Chambers, the Libertarian Party's chair, acknowledged that "to have Libertarians on the APOC board is kind of an oxymoron," given that Libertarians typically support limited government and less regulation.

But Chambers added he's excited for the change, which he said his party hopes to use to try to loosen APOC's stringent fundraising and disclosure requirements.

"If we had the effect on the APOC board that we would like to, it would be a much simpler process and much easier to understand," Chambers said.

APOC won't see any changes take effect until March at the earliest, which is when the term of one of the current Democratic APOC commissioners, Elizabeth Hickerson, expires.

At that point, Walker will get to choose from a list of four names submitted by the Libertarians -- a list Chambers says will include Clift; the party's most recent U.S. Senate candidate, Mark Fish; and two others. Gubernatorial appointees must then be confirmed by the Legislature. The other Democratic APOC member's term expires in 2017.

Asked about its impending loss of APOC members, a spokesman for the Alaska Democratic Party, Zack Fields, responded: "Winning the governor's race was more important than having members of a certain political party on APOC."

LNC REGION 2 REPORT

FLORIDA:

Adrian Wyllie, the first ever Libertarian branded candidate for Governor scored 3.75% of the vote. It's pretty clear that his vote affected the outcome as Governor Rick Scott was re elected by defeating Democrat, Charlie Crist 48% to 47% Bill Wohlsifer, the first ever candidate to run as a Libertarian for Attorney General in Florida, garnered 3%.

There were 4 candidates running as Libertarians for State House. Franklin Perez received 32% which was the highest percentage. of the 4.

Two candidates for Soil and Water Board, one in Collier County and one in Palm Beach County were each unopposed in their respective divisions, so they both got on their Boards.

The main project of the LPF for the near future will be to attempt to become a major party in Florida by getting 5% of the registered voters in Florida to register as Libertarians. This will be a huge task as an additional 600,000 will be needed.

GEORGIA:

Christine Austin qualified last week to run for Georgia State House district 50 in a Special election to be held January 6. Although this is a non-partisan race, she has declared as a Libertarian Party candidate. For those who wish to donate to her campaign, donations may be sent to:

- * We won re-election in two races in Indiana. Steve Coffman and Cheryl Heacox both reelection to their township governing body boards.
- * Our lawsuit, Rufer vs. FEC, was dropped due to the D.C. District Court decision to reject our request for a three judge panel. Rather, the case would have been decided en banc, by all district judges. Our attorney did not feel the make up of the district's court appointments was favorable to our case. It is shelved for now, with the possibility we will bring it back possibly in a different district court.
- * 2015 convention planning is well underway. The convention will be held in Lafayette, Indiana, April 24 26.

Litigation against KET continues. Thank you all for your support. Our attorney is optimistic. We've made a motion to flip the case to a civil jury trial, where we believe we have a great shot at a positive outcome.

LPKY continues to grow. Despite a bad recession continuing, we have increased membership and annual donation revenue. Our voter registration was at 4456 as of mid-November.

2015 is our executive branch election year. If we are to run in the 6 elections we would have to collect a minimum of 5000 signatures on 6 forms (30000 signatures minimum). To date, a few people have been eyeing a few offices.

We have organized our 4th county affiliate. We're really pushing county affiliates.

Members in our last unorganized Congressional District are trying to organize a District Party. It's a geographically-difficult region of our state (eastern KY).

Michigan

The Libertarian Party of Michigan ran 37 candidates in partisan races. Not unexpectedly, LPM candidates were unable to beat any of the Republican and Democratic Party candidates they faced. While this is the fewest number of candidates run since 1992, Libertarians had much better than average election returns, even setting a couple of "minor" or "third" party records in the process. Libertarian candidates beat all other minor party candidates for Governor, Secretary of State, Attorney General, and US Senator.

Mary Buzuma earned 35,570 votes (1.13%) for Governor, the best showing ever for the Libertarian Party of Michigan and second highest result for a third party since at least 1972 when the Libertarian Party was founded (and the starting point of my election results spreadsheet).

James Lewis earned 60,874 votes (1.98%) for Secretary of State, the most votes ever for a Libertarian and the largest percentage for any minor party candidate since at least 1972.

While the number of LPM candidates for the State Legislature was an all time low, the average percentage for State House (4.96%) and State Senate (4.47%) were an all time high. These races included a couple of notable outcomes. In the race for State House District 61, Libertarian Michael Stampfler earned 2,941 (8.88%) which is the second strongest showing in a State House race for a Libertarian Party candidate since Jon Coon earned 5,042 (15.74%) in 1996. In State Senate District 20, Lorence Wenke earned 7,263 votes (9.03%), the strongest showing ever for a minor party candidate for the State Senate since at least 1972.

The LPM ran 12 candidates for US Congress, averaging 2.03% and beating other minor party and independent candidates in 10 of these races. This is the second consecutive election that the LPM has averaged more than 2% for US Congress, just short of 2012's record of 2.31%.

LP Nevada is currently working on 9 bills with the Nevada Assembly and the Nevada State Senate.

Mr. Pojunis does not want LPHQ to publish any election results at all.

He says "we should not be celebrating winning a mosquito control district". He specifically asked me to quote him on the following. Instead of transcribing what he told me on telephone, I will just quote his recent e-mail to the State Chairs e-mail list:

"The report should say, "We are excited that we continually see increased vote totals for Libertarian Congressional candidates. We are preparing for the 2016 elections and hope this trend should continue. The best way people can help is by donating to the Libertarian Party which will give us additional resources."

Otherwise I can sum up all the work... Libertarians lost, actually got killed in all real races in 2014.

Although the LP of Nevada did not win any elections last month, that was not their intent. They used the November 2014 elections as a dry run for a serious attempt at elections in 2015 and especially 2016.

The on-line version of the LP of Nevada's Libertarian Voter Guide received over 39,000 views. I suggest you take a look at it – it's pretty impressive:

In that guide, Libertarian candidates got an automatic endorsement.

For the rest of the candidates, LP Nevada formed an 18 member committee that interviewed over 100 candidates.

Those candidates were either major party, minor party other than Libertarian, or independent. They endorsed some of those candidates for non-partisan races, and they graded all of the candidates in partisan races.

As you probably know, Nevada only has two major population centers: Reno in the North, and Las Vegas in the South. Even though it is over 300 miles from Reno to Las Vegas, they had several non-Libertarian candidates make the trip from Reno to Las Vegas solely in an attempt to get a good grade from the LP of Nevada.

There will be a joint meeting of the Executive Committees of the Libertarian Parties of California and Nevada during the weekend immediately preceding the weekend of the New Orleans LNC Session. After an introductory plenary session, the two EC's will split up for separate sessions, and then get back together for a Saturday night social event.

New Mexico

I thank LP of New Mexico Secretary Elisheva Levin for giving me this update.

Two members of the LPNM Central Committee have been working on marijuana decriminalization: they helped get signatures for initiatives, and called into radio shows. One of those initiatives passed – the penalty for possessing marijuana in the city of Santa Fe is now a \$25 fine.

The other initiative was supposed to be on the ballot in the city of Albuquerque. That one was not put on the ballot for a technicality, and that issue is currently being litigated in the state Supreme Court.

The Catron County LP is sponsoring a Wilderness Medicine Course to increase knowledge about this topic, and to increase awareness of their county affiliate.

Ms. Levin is involved with the Article 5 Convention of the States organization. Their goal is to convene a Convention of the States to propose amendments to the US

Constitution. She is currently the unofficial LPNM Representative, and she will probably be confirmed as their official representative to that organization the same weekend that we are meeting in New Orleans.

Matt Kibbe of Freedom Works will be the keynote speaker at the LPNM Convention in April 2015.



Region 4 / California Report

The Libertarian Party of California' voter registration continues to grow, with the most recent count at 120,804. This has increased by 36,342 over the past five years, as indicated in the graph below. Among other things, this means that the Libertarian Party will remain a qualified minor party in California for the foreseeable future, so that our Presidential candidate will always be on the general election ballot. Unfortunately, Top Two keeps our candidates out of most of the other down-ticket partisan races, so there is more of an effort being put into local non-partisan races.



On December 6th the LPC Executive Committee held a joint meeting with the Nevada LP followed by its separate meeting, and among other things authorized its Operations Committee to negotiate with hotels to hold the 2015 state convention (tentatively scheduled for April 16-19) in Las Vegas. The LPC Executive Committee now includes two elected officials: Calimesa Councilman Jeffrey Hewitt and West Valley County Water District President Jim Hoerricks.

Numerous county LP organizations are active and holding meetings, holiday parties, and in many cases elections for new officers. Details are available on the LPC web site (ca.lp.org).

This report will provide information concerning activities of the Libertarian Party state affiliates in Region 5 since the LNC meeting in September 2014. I shall provide an updated report at the LNC meeting in New Orleans should additional information become available.

I am pleased to report that I have been able to represent the LP in various ways since the previous LNC meeting. For example, I continue to serve as a frequent guest on a two-hour political talk show that airs on weekdays on WINA radio (1070 AM in Charlottesville, Virginia).

Delaware

Scott Gesty (gesty4congress@aol.com) is the chair of the Libertarian Party of Delaware. I did not receive a report from him.

District of Columbia

Ryan Sabot (<u>ryan.sabot@dclibertarians.org</u>) is the chair of the Libertarian Party of the District of Columbia. I did not receive a report from him.

Maryland

Bob Johnston (<u>bob.johnston@live.com</u>), chair of the Libertarian Party of Maryland, provided the following report:

The Maryland Libertarian Party became the first non-establishment party in over 40 years to retain ballot access, as the MDLP gubernatorial candidate Shawn Quinn received 1.5% of the vote in the November general election.

If a political party in Maryland does not have at least 1% of the registered voters as of the last day of the year, the party's top-of-the-ticket candidate must get 1%.

To retain ballot access, the LP's 2016 Presidential candidate must get 1%, or the party must have 1% of the registered voters. In 2012, LP Presidential candidate Gary Johnson got over 1% in the state.

In addition, MDLP Attorney General candidate Leo Dymowski garnered over 56,000 votes, the highest amount of votes for a non-establishment party statewide candidate. Ralph Nader received over 50,000 votes when running as the Green Party candidate for President in 2000.

In Garrett County, Leo Martin got over 28% in a 2-way race for Garrett County Commissioners, and Bill Welch received 10% and finished ahead of the Democrat candidate in a 4-way race in another Garrett County Commissioner district race.

The Libertarian Party of Maryland is working with coalition partners in the Marijuana Policy Coalition of Maryland to advocate for a marijuana legalization legislation as well as a bill that fixes the decriminalization bill the coalition helped pass in 2014. Maryland LP vice-chair Eric Blitz is leading our effort in this cause.

Towards that end, the coalition is sponsoring a Lobby Day (a coordinated legislator lobbying effort), a marijuana policy educational event exclusively for legislators, a public rally in the state capitol, a coordinated advocacy testimony before legislative committees, an email/letter/phone call campaign to legislators, and an activist training seminar to guide grassroots supporters towards effective participation in these endeavors.

Behind the scenes, the party is working within the coalition to gather bill sponsors and supporters, broaden the base of organizations and personalities who are giving public endorsements of the coalition's efforts, and lobbying key local legislators and committee chairs to build support for these bills.

The Maryland LP has 14,771 registered voters, as of October, 2014. The party is looking to run a full slate of candidates for the eight US House seats, as well as the US Senate seat, and also run candidates for the Baltimore City Council. There are no races for the state legislature until 2018.

The annual holiday party will be held at Stu Simms' home in Laurel, MD on Saturday, Dec. 13.

North Carolina

J.J. Summerell (<u>ijsummerell@worksiteinsight.net</u>) is the chair of the Libertarian Party of North Carolina. He provided the following report (which I have edited slightly):

It is really an exciting time and I am honored to represent our state.

First, though Sean Haugh lost his US Senate bid with 3.9% of the vote, he brought LOTS of attention to the LP and LPNC as the difference between Hagan and Tillis was less than 2%. Newsweek ran this article (www.newsweek.com/libertarian-pizza-delivery-guy-sean-haugh-might-decide-fate-senate-279400) and NPR ran one (www.npr.org/2014/10/14/356142508/pizza-man-and-other-third-party-candidates-shake-up-tight-senate-races) as well. Ballotpedia has links to numerous other articles (http://ballotpedia.org/Sean_Haugh).

Secondly, and even more exciting, is that Project 2020 (the strategic plan) is finally coming to fruition. It has been a 2+ year project. Jason Melehani's analysis of each of the NC House districts is particularly important and interesting, for these reasons:

- 1) The NC Republicans just got rid of straight ticket voting.
- 2) Of 120 NC House seats, 55 were unopposed as a result of gerrymandering.
- 3) Of those 55, there are 18 where the R/D registration numbers are less than 15% different and there are more than that many "unaffiliateds"

That is, if we can motivate the D's to vote in R gerrymandered districts and the R's to vote in D gerrymandered districts, the numbers suggest we could actually elect an L to the NC House. It will take quite a lot of work, but the stated goal of 2020 is one elected representative to the NC General Assembly in 2020. NC House seats are elected every two years, so that gives us 2016 and 2018 to prepare.

Over the next few weeks we should be pulling this all together into a more cohesive plan.

Pennsylvania

Virginia

LP Iowa had candidates in 11 races in the 2014 election. All candidates ran good campaigns that were professional and respectable. We provided voters a choice.

Governor: Lee Hieb was 1 of 5 candidates on the ballot for Governor and she came very close to meeting the 2% of votes needed to enable us to obtain major party status. She received 1.8% of the vote, the most ever by a Libertarian running for Governor in Iowa. Lee was a guest on several radio and TV programs, which allowed her to reach voters statewide.

<u>U.S. Senate:</u> We lost U.S. Senate candidate Dr. Doug Butzier in a plane crash a few weeks before the election. Many voters still voted for Doug as a tribute vote. Libertarian Rick Stewart was so passionate about campaigning about liberty that he ran as an independent. Rick covered the state twice and received 26,566 votes for 2.4% of the vote in a 6-person race.

<u>U.S. Congress:</u> In a 4-person race, Ed Wright garnered the most votes and the highest percent of votes (3.2%) ever by a Libertarian running for U.S. Congress in Iowa. Many voters decided to "Choose Freedom", Ed's campaign slogan.

<u>Secretary of State:</u> This was Jake Porter's second bid for the Secretary of State office. Jake received 3.0% of the vote in a 4-way race and used his campaign experience to help other candidates.

<u>Treasurer of State:</u> Keith Laube received 36,804 votes (3.4%) in a 3-way race where the incumbent won a 9th consecutive term. Keith received the most votes ever for an Iowa Libertarian running for Treasurer of State and the 2nd most votes ever by a Libertarian candidate in Iowa.

<u>Iowa General Assembly:</u> Iowa Senate candidate Tom Thompson and Iowa Representative candidate David Overby received 3.5% and 2.9%, respectively, in 3-way races. In 2-way races, Iowa Representative candidates Eric Cooper (District #45), Brian Cook (District #96), Lynne Gentry (District #10) and Joshua Herbert (District

#31) each received more than 20% of the vote in their race. Eric Cooper received the highest percent of votes (24.4%) ever by a Libertarian running for the Iowa House.

Iowa has made significant gains in the number of registered Libertarians in Iowa during the last few years:

spring 2012 - 1,550 spring 2013 - 2,240 spring 2014 - 3,284 November 2014 - 4,775

Our goal is to have 25,000 registered Libertarians, which is approximately 2% of the vote. A party's candidate must obtain 2% of the vote for Governor or President to obtain and keep major party status in Iowa.

We will be having an elections recap/strategy meeting after the holidays. We will discuss where we should put time and effort to grow existing county parties and where to start new county parties.

The low voter turnout has resulted in a lower threshold for statewide ballot access down from 44,000 to just under 40,000.

There was increased interest in the ballot access lawsuit with good attendance for the oral argument. Alabama is working on lobbying to reduce the number of signatures for ballot access and a lawsuit to extend the deadline in presidential years from March to June or September for party label.

Jefferson County is having restaurant meetings once a month and LPA has monthly Ex Com meetings at the new office which moved in September

Petitioning for 2016 has already started with a few hundred signatures collected so far, from Jefferson County. It can be decided later whether to turn them in to the county, which will give county access with about, or the state.

Arkansas – No data was reported.

Louisiana - Louisiana fielded it's largest contingent of candidates ever for a single election date with 19 candidates qualifying (13 local and 6 Federal).

In the November/December, 2014 elections Louisiana elected more Libertarians to office than any other state in the country.

Louisiana scored its first ever head to head victory for a Libertarian against an opponent when William McBride defeated Republican Laura Budden to win the district 3 seat for Washington, La City Council.

Louisiana garnered it's first ever run-off by Chad Perry of Vinton, La running for Calcasieu Parish Justice of the Peace, Ward 7,. Mr Perry won the run-off on Dec 6th defeating his Democratic opponent.

Henry Herford won unopposed Constable, Justice of the Peace District 1 in Franklin Parish. Justin Bonnette won unopposed Justice of the Peace Justice of the Peace Ward 6 in Vernon Parish.

Louisiana's Randall Lord garnered the largest vote percentage in the whole country by a Libertarian running for Federal Office with 26.6% of the vote.

Louisiana has grown from to 10,877 with the party being up almost 10% since hitting 10,000 registered Libertarians on September 28th of 2014. Louisiana has some great upcoming outreach opportunities allied with other organizations on some key focus issues, such as the petition to amend the New Orleans Home Rule Charter that should drive registration even faster.

Louisiana has formed more local affiliates in the last 2 years than any other state. From March 2013 to present Louisiana has formed 18 Parish Executive Committees with 1 more scheduled to form on January 4th. That's 28.1% of the state already organized at the local affiliate level with right under 30% set to be organized by January 2015.

Louisiana has also begun to establish campus affiliates(College Libertarians) we are making great gains in registration on campus. So far Organizations have been established at LSU, LSU-S, UNO and Bossier Community College.

The Libertarian Party of Louisiana has one of the most successful donor bases having brought in over \$28,000 and on pace to bring in over \$30,000 for the year not including money raised by our local affiliates. LPL donors have been instrumental in the successful growth.

The Libertarian Party of Louisiana is proud to host and welcome the Libertarian National Committee.

Mississippi - Mississippi is excited about the connections made coming out of the 2014 election cycle and looks to take advantage of these new alliances to help grow the Libertarian Brand, Mississippi is having a great increase in inquiries to run for office in the upcoming election cycle in 2015.

Mississippi has been experiencing great interest among the the young voter segment as more and more are identifying with the Libertarian Philosophy and Party instead of establishment parties. Mississippi is working to implement college affiliates to take advantage of this increasing trend.

Oklahoma – No data was filed.

Texas – During the State Libertarian Executive Committee meeting on December 6th, the committee passed a strategic plan that had been in development over the previous six months. The plan

effectively restructures the functions of the state entity into departments for ease of workflow and effective communication with volunteers/personnel.

This is the most geographically compact region, but each state has very different politics and processes.

I've made it to more events than last term, and hope to continue doing so. We may do another joint event, perhaps a candidate or legislative training. Would like more members to subscribe to the *LP_8new* yahoogroup.

Heading into 2014 elections, only Vermont had realiable ballot access. Petitioning would either be eliminated or become easier if party status were obtained, except in Massachusetts where it would become more difficult.

Coming out of the election, no changes to statewide ballot access despite some early positive news. Given the timing of the 2016 convention, this lack of ballot access will require resources from either National or the presidential campaign to put our presidential nominee on the ballot in some of the states.

There were some definite highlights, including candidates in Connecticut, Massachusetts, New York and Rhode Island setting local records. We also witnessed new levels of statist nastiness in New York with the challenge to several candidates including a gruelling effort against Gigi Bowman.

Campaigns and Election Results

LPCT ran two candidates in 2014: Rich Lion for State Rep and Dan Reale for Congress. Rich Lion for State Rep, District 9, ran an active campaign, leaving thousands of door hangers and placing 100 yard signs. He received 15% of the vote. Mr. Lion left his job temporarily in order to campaign. He received the highest percentage of the vote received by a Connecticut Libertarian who did not win, and the best performance to date in a state legislative race.

Dan Reale, running for Representative in Congress, 2nd District, placed more than 100 yard signs. He received 1.1% of the vote and retained ballot access. This is the second time in a row that Mr. Reale retained ballot access. This time around, he faced a contentious convention in which he was challenged by the Republican for our nomination.

The LPCT currently has two elected officials. All races in Connecticut are partisan.

Future Growth

We are currently encouraging members and interested people to attend local meetings and consider running in next year's municipal elections.

The LPCT is engaged in a major fundraising effort with the hope of raising seed money to hire a part-time employee. We have sent letters to 1,500 people. In January, we will launch an email fundraiser for the purpose of funding the 2015 local races—the goal is to raise enough money to place all endorsed candidates on the ballot with paid petitioners, and to provide all candidates with a website, professional photograph and brochure.

Ballot Access

LPCT chairman Joshua Katz testified against the cross-endorsement law (PA 13-180).

We are working with LP National and the ACLU to overturn some of the more onerous provisions in state ballot access laws, including restrictions on who can and cannot petition, and challenging the requirement that petitioners live in-state as unconstitutional. We have retained Day-Pitney in the lawsuit challenging the ban. The lawsuit will be filed during the next legislative session.



Social Media

The LPME Facebook page has more than 801 likes, up from 680 in March.

Healthcare

The issue is coming up again in Maine. Some Maine nursing homes are threatening to close due to inadequate funding from MaineCare, the Maine Medicaid program. Legislators fear a backlash from relatives of nursing home patients and house, senate and Gov. LePage will undoubtedly find funds to add to MaineCare budget. 78% of nursing home care in Maine is funded by MaineCare and Medicare and Maine Nursing Homes are 92% full.

We pointed out four key problems with the current system along with simple promarket solutions to create greater availability and quality of care.

The Future

We will be looking at new party rules in Maine which may ease the way for us to become a recognized party, devil is in the details however. The effort will center on a voter registration drive.

We will need about 5000 to qualify so we will need 6000 signatures to ensure we have enough valid signatures to submit. We will have one year to get all the signatures so it shouldn't be difficult to meet our goals.

The difficult part for us will be voter turnout and registration after getting ballot access. We just may be repeating the same process every two years.



2014 State Convention

Held on Saturday, October 18 in Worcester. There were 18 credentialed delegates and about 10 guests. Evan Falchuk, an independent candidate for governor spoke to us, addressing many of the same concerns libertarians have with state government. Officers reported operations are running smoothly, though more help is always appreciated, our finances are stable, though membership is down about 20% but that may be due to some hiccups in 2013 newsletter delivery.

We elected 8 members to the state committee: Dan Fishman, Heather Mullins, Steven Sadowski, Ken Van Tassell, Cris Crawford, Alwin Hopfmann, Robert Clark and George Phillies. Five of our candidates spoke about their campaigns, upcoming efforts and media coverage.

Rich Tomasso gave a summary from the LNC, the region and across the country. He reminded members that the LNC will be voting on the budget in December and making appointments to the Bylaws and Platform committees next year, so get your ideas in early.

Joshua Katz, Chair of LPCT and alternate LNC rep, gave the keynote speech about the importance of running for local office and the impact you can have as a local official. He addressed the barriers the establishment puts in place and how to be clever to get around them to get our message out and to affect policy. Key part of being accepted is being reasonable and working with others, show you are responsible with the reigns of power and you will gain trust of the electorate.

Mr Katz announced an exploratory committee for a presidential run. He answered questions about that afterward. He has since dissolved the committee.

General Activity and Outreach

We hold monthly meetups in the Boston area and we have five regional meetups established. Our Facebook page has doubled the Likes in the past year! Our Twitter presence grows with regular postings. The newsletter includes items of general interest and practical aspects of Libertarianism, and we publish it on a regular schedule.

If anyone would like to partner or cross-advertise events, email us partners@lpmass.org We continue to be active on social media, pointing out efforts of our legislature and police to trample more of our rights and calling out stupid regulations that stifle innovation.

2014 Elections

The electoral efforts were focused on the legislature rather than the executive branch. Candidates got press coverage, got radio interviews and were invited to debates.

Hassan A. Smith has a radio interview and other news on his facebook page.

Heather Mullins got great coverage, including the front page of the Cape Cod Times after her first debate appearance. www.heathermullins.net

Our 2014 Massachusetts State Rep candidates did really well by comparison with historical outcomes. We had new top performer, three in the top six (going back to 1992), two people squarely in the middle, and one man who did a career change in mid-campaign. We also had a State Senate candidate in a first-time three-way race, and our first-ever candidate for County Sheriff.

What did we do that was different? Our State Party made our legal-maximum donation to each candidate, and a major get-out-the-vote effort in each district where we had someone for whom to vote. The latter was Federal Election Activity, so we could support it with Federal Funds as FEA. We did a Facebook campaign and spent modestly above \$1000.

Social Networks and Website

Our Facebook Group has 582 members, our Page has 339 Likes, and we have 1085 Twitter followers (@LPNH). Our website backlog grows, but a recent software upgrade should help. We need a new webmaster to take on several projects. Some people have come forward, but never reply to followups.

Candidates

None of our major candidates made it on the ballot but all ran write-in campaigns. This could have been our year, but we will deal with it. Perhaps the liberty community will realize their mistake of trusting the GOP and come back to support us as a useful counterweight to the establishment crowd. If everyone who complained about not having a Libertarian to vote for had done some petitioning we'd have made the ballot with plenty to spare.

Lisa Wilber, our state rep candidate, got a nice article in the Sunday *Concord Monitor* right before the election. Lisa earned 969 votes, or 11%, coming in 6th of 9 candidates. She beat one Democrat and came within 50 votes of beating another one.

Lawsuit

With the NHCLU we are suing the state over yet another change to the law to make life harder for third party and independent candidates. The latest change wiped out 2/3 of the time we have to complete a party-wide petition with no corresponding reduction in the number of signatures, effectively making the task impossible. We found a very favorable precedent from Rhode Island for nearly the same situation. The case is still in discovery phase. The case was featured at their annual *Bill of Rights* dinner in October.

The state has made a motion to dismiss and our response brief is in the works.

General and Future Activity

The Freecoast Freedom Festival was a success, with libertarians coming from all over New England. Even Vera Kichanova flew in from Russia as part of an extended vacation.

Getting members involved is still difficult. A few people have come forward finally, though I do need a few more to make a big enough team.

We are in the process of organizing a state convention. Hoped to have it in November, but it is now pushed out to January. The main business will be electing new officers and deciding on a plan for the next two years.

A sizeable bi-partisan liberty caucus is in the statehouse now, so we have lots of friendly legislators to work with. The leadership is still being sorted out and is usually where we face real challenges on the big issues we care about. I expect we'll make the most progress on fiscal and regulatory issues for the coming session.



Recent News and Events

We challenged the D's and R's automatically claiming the first ballot columns after they failed to get enough votes in the primary. We didn't win, but definitely highlighted the dwindling support for the two old big-government parties. We've had preliminary talks about legislative remedies to this situation.

Effective communication is critical for the success of Libertarian Candidates and Activists. On September 21, Jim Tosone and Ken Krawchuk hosted a workshop designed to help candidates and activists convey the message of liberty, and turn NJ residents into Libertarian supporters and voters. Ken, began the session with a series of talks based on his personal experience running for a variety of elective offices over the years. The topics covered were "How to Run a Campaign," "How to Go Door-to-Door," and "Why Vote Libertarian?" Ken and Jim then conducted a mini-master classes in prepared speeches. Two of our candidates, Joe Baratelli and Steven Uccio gave stump speeches to the audience. Ken and Jim then gave each candidate feedback on their speeches: what worked well, and ways they could enhance the substance of their talk and their presentation style. The candidates appreciated the constructive comments. The program ended with a Q&A session

We hosted "Liberate Trenton" on 10/25 at the Trenton Public Library. It was a free discussion of issues facing urban communities in New Jersey, including education, the war on drugs and jobs.

We had a general post-election party meetup on November 8th in North Brunswick.

We publish a quarterly newsletter and have regular updates to our website. We're involved in many efforts from watching local government to fighting corruption, eminent domain abuse, poor public works, mismanaged government projects and more.

Eminent Domain and property seizures are big news in the Garden State, we've made regular commentary on the matter, even taking a stand to protect a judge's home from being seized via a ballot measure by irate citizens.

Chairman Patrick McKnight was recently published in the *Times of Trenton* and *NJ.com*.

The NHLP is the third-largest and fastest-growing party in the state! We are the only growing party! We are very excited and energized about the future! Challenging Our Candidates

12 Libertarians filed for public office. Nearly all our candidates were challenged, seeminly because they could be. In all, four Libertarian candidates were kicked off the ballot.

All 5000 of **Gigi Bowman**'s signatures were challenged by her opponent and his paid staff. Late objections cast enough doubt on several of Bowman's petitions (the NY form has alot of spaces to fill in). We fought and it was an up and down ride. We lost the hearing in Albany on Oct 16th. The judge ignored the precedents we cited and the decision made no mention at all of our equal protection constitutional claim, relating to the unequal treatment of petitions to validate, as if that argument didn't even exist. We appealed to the next level. Ultimately the appeal went up four levels of the court system, but we prevailed! On Oct 24th the court overturned the earlier decisions, primarily for late paperwork from the opposition. The opposition filed an error-filled appeal on the 29th, but was competently rebutted by our council. Score one for the good guys, and we used their own precedents against them!

Kudos to **Gary Donoyan** who took the case and defended Bowman with a lot of energy and diligence and gave up many hours of sleep. The lawsuit took a toll on the campaign, as the opposition was able to get the media to drop coverage of Gigi Bowman and force her to take resources away from talking to voters and instead defend her place on the ballot. So while we did win, it was a costly win. The statist will use tactics like this to hinder the effort of liberty. Thankfully her supporters barraged the media for their sloppy coverage and it fired up the LPNY team to fight hard against this nonsense in the future. The shenanigans continued right into election day with the posting of sample ballots without Bowman's name on them.

Press Coverage and Endorsements

The challenge to **Gigi Bowman**'s petitions got local press coverage. Gigi and party chair Mark Axinn called out the incumbent for trying to silence his competition and reduce the choices available to the voters and not upset the apple cart of the corrupt nature of NY politics.

Mike McDermott was included in debates with his old party opponents. Mike also got coverage in print and radio. The Mike Vogel column in *AM New York* asked voters to skip the big parties and vote Green or Libertarian. Jimmy McMillan, founder of the Rent is Too Damn High Party, endorsed McDermott.

Candidates

Libertarians successfully petitioned for a statewide office for the first time in a midterm year. The party placed **Tony Jones** of Wickford on the ballot for Lieutenant Governor.

Jones' campaign focused on the elimination of the office of Lt. Governor, which costs taxpayers roughly \$1 million per year. The Lt. Governor does not have much power to wield in state government and many argue the position has long since lived out its usefulness.

Tony Jones generated a fair amount of media, including TV coverage on NBC Channel 10 in Providence.

Regulate Rhode Island

Tony Jones released a statement calling for Rhode Island to become the next state to tax and regulate marijuana like alcohol. He pointed out the harm reduction and business growth in Colorado and Washington thanks to their recent initiatives.

"As candidate for Lt. Governor, I'm proud to be a member of Regulate Rhode Island, a new organization leading the movement to regulate and tax marijuana like alcohol. In 2015 Rhode Island has the opportunity to become the first state on the East Coast to end the costly and destructive policy of marijuana prohibition."

Stopping Agenda 21

A new push to implement Agenda 21 called "Rhodemap RI" is working its way through the legislature. The LPRI is strongly against this and encourages all members to get involved. We passed a formal resolution against this "grand experiment in extreme environmentalism and collectivist social engineering whose objectives include income redistribution, minimizing the authority of local governments, income-based housing quotas, an expansion of eminent domain at the expense of property rights, and increased government influence over many areas of our lives."

The advocates scheduled a meeting on November 20th but had to postpone to Dec 11th due to all the bad publicity that's been raised and the outpouring of citizen action against it.

The Future

Now that the election is over, properly reorganizing the LPRI is chairman Mike Rollin's very top priority. That will get started at our executive committee meeting on Dec 7th. Here in Rhode Island Tony Jones set a new record for Libertarian Party candidates with his nearly ten thousand votes. Beyond that, Bob Healey, who actually called himself a libertarian during one of his debate appearances, got 22% of the vote. We thus do have an obvious libertarian base here in Rhode Island that is ready, and waiting for us to organize it. Any, and all help that we can get from the national LP will be extremely welcome toward our efforts!



Vermont Candidates

The **Dan Feliciano for Governor** campaign is drawing in support from all affiliations. On the eve of the GOP primary, several prominent GOP leaders endorsed Dan as a write-in. He came in 2nd! Dan participated in a televised debate and was broadcast on CSPAN. The debate became a social media hit for the interesting cast of characters running for governor.

In all, we nominated 15 candidates for the general election! Travis Spencer, John Cisar, Ben Mayer, Glyn Wilkinson, Christopher Coolidge and Paul Washburn for State Senate; Loyal Ploof, Ray Collette, Varpilah Chase, Lillith Soleil, Dana Rushford and Ted Schaft for State Representative; Owen Mulligan for Sheriff of Chittenden County, Jonathan Stauffer for High Bailiff of Chittenden County; Loyal Ploof and Roy Collette for Justice of the Peace.

Outreach and Coverage

The Vermont LP participated in the 2014 Pride Vermont Parade on Sunday September 14th. Several members and candidates participated. One of our featured candidates, John Cisar for Vermont Senate received a close up from FOX44 Local News.

Channel 17/Town Meeting TV filmed the Chittenden county state senate forum including Libertarian state senate candidates: John Cisar and Paul Washburn.

Loyal Ploof debated four of his opponents on Burlington TV.

In Essex, Varpilah Chase debated two incumbents on Channel 17/Town Meeting TV.

Libertarian National Committee meeting New Orleans, Louisiana December 13-14, 2014

Dear Colleagues:

If we lived in a nation with just election laws, we wouldn't have to pursue ballot access. Unfortunately, that is not the case. The following memo addresses petitioning opportunities for the LNC in 2015 and 2016.

I want to thank Richard Winger and Bob Johnston, LP of Maryland Chair and an Independent Contractor to the LNC, for their assistance in updating this report.

We currently have ballot access for our 2016 Presidential ticket in the following 30 states: AK, AZ, CA, CO, DE, FL, GA, HI, ID, IN, KS, LA, MD, MI, MS, MO, MT, NE, NV, NM, NC, ND, OR, SC, TX, UT, VT, WV, WI & WY.

I will now address the other 20 states and DC:

AL: The LP can start a party petition anytime (39,975 valid sigs), but I presume that we will do an Independent petition for 5,000 valid sigs in 2016 after the Presidential nomination. I budget \$15,000.

AR: I have not yet been in contact with the LPAR regarding their desires, but I presume that the LPAR will want to do a party petition for 10,000 valid sigs that we could do in 2015. I budget \$30,000.

CT: 7,500 valid sigs in 2016 for President. The LPCT is working with the ACLU to possibly litigate the out-of-state petitioner ban in CT. This drive will likely need some subsidization from the LNC. I budget \$25,000.

DC: I estimate a 4,600 valid sig petition drive for President in 2016. I budget \$15,000 from the LNC.

IL: 25,000 valid sig petition drive for President & US Senate in 2016. I will budget \$66,500, which was the budgeted amount for 2014.

IA: 1,500 valid sig petition drive for President. This required subsidization in 2012 from the LNC. Hopefully not in 2016.

KY: 5,000 valid sig petition drive for President can start the day after Election Day 2015. I budget \$7,500 in 2015 and \$7,500 in 2016.

ME: The LPME is working with Scott Kohlhaas in a voter registration drive. The LPME needs 5,000 registered voters to become an officially recognized political party in Maine, which would give the LPME ballot access. This registration drive cannot start until December 2014. It will have to

conclude by December 2015. Scott Kohlhaas anticipates this registration drive will succeed. I am not planning on any LNC subsidization at this time.

MA: We will need to do a 10,000 valid sig petition drive for President after Memorial Day 2016, unless we receive permission from the Secretary of State to list only our Presidential electors. If we got that permission, the petition drive could start in February 2016. Deadline: August 1, 2016.

Please note that if we had party status in MA, we would not have to petition at all to get our Presidential ticket on the ballot there.

MN: A 2,000 valid sig petition drive for President after the Memorial Day 2016 weekend convention. I will plan on this being done by the LPMN.

NH: 1,500 valid sigs in each of two congressional districts (3,000 valid sigs total). I have not seen anything out of the LPNH recently that would indicate that it could handle this petition drive on its own. I budget \$15,000 in 2016.

NJ: 800 valid sigs after Memorial Day 2016. Although the LNC needed to subsidize in 2012, I would hope they could do this on their own in 2016.

NY: We will need 15,000 valid sigs for our Presidential ticket in 2016. I budget \$30,000 from the LNC.

OH: The LPOH is still in court regarding Ohio's ballot access laws. We should see how this litigation plays out before considering what to do with Ohio for 2016.

OK: A party petition would be 41,242 valid sigs. A presidential petition would be 40,047 valid sigs. The cost to do an LPOK petition drive would likely be about \$125,000. NOTE: This dollar amount is not included in the 2015 & 2016 summaries below.

PA: We are looking at probably about a 25,000 valid sig petition drive in PA starting in February 2016. We are probably looking at an expenditure of \$70,000.

RI: A 1,000 valid sig petition drive. I don't think the LPRI can do this themselves. We are probably looking at an LNC expenditure of \$2,500.

SD: The LP will lose its party status in SD in November, because the LPSD did not run someone for Governor this year. However, the LPSD has a new Chairman, Emmett Reistroffer, who seems to have a great desire to move the LPSD forward. A party petition for 6,936 valid sigs would get us two elections (2016 & 2018), with a possibility of retaining ballot status if we get 2.5% for Governor in 2018. I budget \$20,000 of LNC funds in 2015.

TN: 275 valid sig petition drive for President in 2016. The LPTN should handle this itself. The LPTN needs to work to get this done well ahead of the deadline in 2016, not let it go to a last day fire drill, as in 2012.

I think there needs to be greater involvement by a National Office employee, presumably the Political Director, in helping our state parties with ballot access lobbying.

Policy Manual Charter:

The LNC Policy Manual states the ASC shall identify the needs and interests of the various affiliates. In addition, the ASC shall identify those affiliates that are in particular need of assistance that the LNC can provide. The ASC shall deliver a report on Nov 10th of each year, identifying and prioritizing those needs and interests of the various affiliates. That ranked list shall be taken into consideration when drawing up the following year's budget, and throughout the year as needed. This list will also assist the Executive Director in deciding how to assign tasks to staff, by identifying those services that staff provides to the affiliates that are the most desired.

The ASC shall also, as and when needed, recommend to the LNC measures that will address the particular affiliates that need assistance from the LNC.

The ASC will also establish a process for tracking the progress in meeting those needs.

Report Attachment: MS Excel file "ASC 2014 Poll Results Rev 0.xls"

ASC attempted to contact a member of the state executive committee of all 51 state affiliates. With the sole exception of Montana, contact was made with a member of every affiliate Executive Committee, either the Chair or VC, so our analysis includes results from 50 of 51 state affiliates – the expected 50 states plus the District of Columbia. The complete raw data for each state is listed in tabs provided in alphabetical order in attached workbook. Social media links are available only in the raw data, and are most easily access in tab "Summary of Responses". Additional tabs in workbook provide analysis calculations or results.

Poll questions included the following:

- 1. Provide rank of LNC service level -1 = lowest, 3 = average and 5 = highest.
- 2. What are the top 3 "needs and interests" in your state?
- 3. What is your #1 need from LNC?
- 4. What would your #1 topic be for a LNC sponsored training seminar?
- 5. What social media link would you like added to your state's page on the LNC website?
- 6. Please share your state's annual cash flow amount.

Analysis results are provided in graphical form, as follows:

- 1. Table LNC Service Level
- 2. Table Affiliates Internal Needs and Interests
- 3. Chart Ranked list of affiliate's #1 need from LNC
- 4. Chart Ranked list of affiliate's #1 LNC training request
- 5. Table Ranked Affiliate Cash Flow

Table - LNC Service Level

Affiliates generally scored LNC's current service as being below average. "Bad" scores were five times more frequent than "Good" scores. The good news is that LNC has room for improvement, and this data can be used to track progress.

Table - Affiliate Internal Needs & Interest

The ASC Poll probably needed to make clearer the intention of this question is to understand what's relevant to the state affiliate within their own state. The raw data appears to intermingle expectations the affiliates have for LNC performance as opposed to internal interests. Nonetheless, some useful intelligence can be gained.

Top needs & interests are fundraising, increasing membership, recruiting candidates, and ballot access. There are many good ideas provided by state affiliates individually in the MS Excel file containing the raw data. Many affiliates have an interest in centralized advertising, branding and integration of state/national infrastructure.

Chart - Ranked List of Affiliate's Needs:

The affiliates were asked to give their #1 needed help from LNC, and these results are summarized in tab "#1 Need Chart". While Ballot Access (qty 9) tops the list numerically, viewed together dBase support (8) and General IT support (4) top the list. From some individual responses, there appears to be a strong desire to have LNC provide such shared infrastructure as dbase integration and & a common business infrastructure — such as a common telephone answering service. It appears clear a lost opportunity is for LNC to provide "volume" benefits that could be gained from a centralized sourcing of infrastructure.

Ranked List of Training Needs:

On the overall list of Affiliate's needs, Training ranked surprisingly low – being only #7 on the list of what the affiliates need from LNC. Top items of interest fell into the general categories of team building, fundraising, candidate / campaign support, and organizational development.

Affiliate Cash Flow:

As provided on tab "Summary of Responses", the total of reporting affiliates income estimate is \$819,100 with average being \$17,807 per affiliate. Of the 50 state affiliates and DC, five organizations chose to not provide an estimate of their annual income. From total income table, the following breakdown on income applies:

1 state: Income >= \$100K 14 states: \$100K >= Income > \$10K 23 states: \$10K >= Income > \$1K 7 states: Income <= \$1K

More useful as a predictive tool is a similar breakdown based upon the weighted per capital value. There is clear difference between higher vs lower income states as show in data on tab "State Bar Chart Data".

If all state affiliates having Income Factors < 30 were to increase cash flow up to 30, then those state affiliates would have an additional \$353,400 to split amongst themselves for their state budgets.

The following state affiliates are known to either currently or recently have had paid staff. The prefix is their respective ranking of state affiliates in absolute cash flow amount: see attached table. High income states without a known paid staff include Illinois (#3 ranked having \$60K), and Arkansas (#8 having \$35K). Presumably, the high income states without staff generally have high ballot access costs.






Recommendations:

- 1. IT funding should be allocated to address the dbase deficiencies, and provide CRM services to affiliate and host on LNC-provided server.

- 4. Budget allowance of \$30,000 to provide training for affiliates including travel expenses, materials and developmental costs.


Poll Question: Rank LNC current service level: "1" is Bad, and "5" is Good






The members of the Employment Policy and Compensation Committee (EPCC) are Brett Bittner, Joshua Katz, and Jim Lark. The members were appointed to the Committee by Nick Sarwark on Nov. 15, 2014.

The EPCC conducted a meeting via teleconference on Nov. 23. During the meeting, the EPCC elected Dr. Lark to serve as chair and Mr. Katz to serve as secretary.

In the near future, the EPCC will distribute a message to staff members. The message will inform the staff that the EPCC is available to discuss (on a confidential basis) the working environment or observed violations of the Policy Manual. (The EPCC is specifically charged with the responsibility to be available to the staff for this purpose; we believe staff members should be informed of this responsibility.)

IT COMMITTEE REPORT

DECEMBER 2014

Committee work has been slow this past quarter with some members focused on elections and other outside commitments requiring time away.

We did meet last week via conference software. Alicia made herself available to run the Adobe Connect software. It has the necessary features to run a meeting, including conducting votes and sharing documents. Overall the system ran smoothly and is much better than a straight voice conference for an actual meeting or to review a proposal or look at a spreadsheet.

We have not named a replacement for Laura Delhomme. She was focused on the website, so we may pick her replacement based on that need once the LNC has decided on a direction for LP.org. Sam and Rich will send out inquiries to a subset of our applicant pool by year end.

Drew Hutton summarized his evaluations of free/cheap project collaboration and project management software. He found that with free you usually get what you pay for, and some free tools don't scale up so well. Rich provided some criteria for typical LP/LNC use cases and needs to narrow down the list. They had come up with some of the same tools in early evaluations.

An open question is what tools are used to track ballot access and petition drives? We are looking at 20+ states with petition drives in 2016 and that could mean managing 100+ petitioners, so it would be good to know how we can do that effectively so nothing gets missed. We recommend a repository filled with all the info Bill Redpath and others have accumulated so it doesn't get lost.

The IT budget request: The latest proposed budget has \$25,000 allocated across two categories. We don't have a specific packages to recommend as yet, but the main items we'd be looking to spend on are a website upgrade/redesign, the shared database project, and upgrades and/or new modules for Raiser's Edge. These seem to be the highest priority and have the most prep work done. The next set would be licensing for new tools and software such as Adobe Connect and some project management software. Those shouldn't be pricey per utility, usually <\$500 each. We will continue looking at more opportunities for savings in our back office and IT operations.

Sam will ask Wes Benedict for details on the Raiser's Edge add-ons we can get along with pricing. We may meet with him before the LNC meeting to go over them.

LP.org: The LNC will have a working lunch to discuss changes to LP.org. To date there have been a number of complaints but not much in the way of specific fixes. We need a serious discussion of the needs and purpose of LP.org before we commit to an RFP. Rich will take point on that discussion, focusing on requirements, usability, audience and transactions.

We're most likely looking at a front-end revamp rather than much with the back-end, though that may change if we decide new modules or integration with Raiser's Edge are needed and possible. The RFP will go out to party members and outside firms once we have a sense of what the LNC wants and settles on how the website fits into the party's strategic goals and growth plans. This should not be anywhere near as expensive as prior bids the LNC has gotten. There is a way to integrate CiviCRM with RE, but it may lock in the versions used for a while, so it should be done after any updates are completed. The consultant LPTexas used said they'd done it.

Report from Committee Appointed to Draft Proposed Rules for Electronic Meetings

For December 13-14, 2014 LNC meeting Submitted by: Estrada, Hayes, Johnson, Katz, Mattson, and Wiener

The committee members quickly realized that we needed to actually evaluate potential host software for electronic meetings before we could have a good feel for what kinds of rules were going to be needed.

We asked LNC members for information about the spectrum of operating systems we needed to attempt to accommodate. Even though only 10 people responded to this request, even that subset of info made it clear we need a host with broad compatibility.

We gathered a list of 12 potential vendors, came up with a spreadsheet of comparison metrics, and started analyzing. 7 of them were eliminated without even testing them because we quickly found deal-killers in their specs. Deal-killers included: some were just screen-sharing systems (no webcamera features) designed for one-way information flow, cost (including one that was 5-digits annually and another high-4-digit one), focus on high-def video such that a wi-fi internet connection was not adequate, failure to support a wide-enough spectrum of operating systems, failure to support any mobile devices, and terms of use that required each participant to agree to receive text messages from the company.

For each of the other 5 potential vendors, we scheduled weekend trial runs to kick their tires. One of those 5 was found to be unviable because it was designed more for webinar scenarios where only one person is presenting and the rest are just listening. When just a few of us tried to all use webcams simultaneously, we experienced extremely throttled bandwidth, poor quality audio that cut in and out, and video that would freeze. It had no hand-raising feature, didn't allow the host to share documents (only video), and didn't let anyone but the meeting host know much about the status of the other participants.

After the trial runs, the other four (Fuze, WebEx, Adobe Connect, and GoToWebinar) were deemed to be potentially viable options. Attached is a spreadsheet spanning two pages showing the comparison metrics for these final four.

Adobe Connect came out as our clear preference, primarily for its ability to allow more simultaneous webcams, its support for a wide range of devices and operating systems, its hand-raising feature, and its extra participant statuses that can be used to conduct votes, share non-verbal feedback, claim preference in recognition, show a participant has stepped away, and many other potential uses. As a side benefit, Adobe Connect was the only one that advertised that it has extra functionality for vision-impaired participants. With all these features, the cost is quite reasonable.

With help from a few other LNC members not on our committee, in testing we were able to successfully connect to an Adobe Connect meeting with Windows XP, Windows Vista, Windows 8, Mac OSX, Linux, iPhone, iPad, and Android devices. We had as many as 11 simultaneous webcams on with good audio and video performance.

Our first proposed rule is that we will use Adobe Connect. It offers the most features accommodate use of RONR. Because of the features of that platform, we found that there were some rules we didn't need to write because the software itself provides a natural and obvious method. The other rules we did feel were needed are attached for the LNC's consideration next weekend.

Proposed Rules for Electronic Meetings

Recommended by committee composed of: Estrada, Hayes, Johnson, Katz, Mattson, and Wiener

1.02 Meetings

6) Meeting Minutes

[snip]

Meeting minutes for face-to-face <u>or electronic</u> LNC meetings may be promoted from draft status to official during the time between LNC meetings as follows: [snip]

7) Electronic Meetings

- a) All electronic meetings will be conducted via the Adobe Connect / Citrix service.
- b) Each usage of the term "committee" within these electronic meeting rules shall be construed to include both the LNC (as the board of the Libertarian Party) as well as committees.
- c) Each committee member calling for an electronic meeting must do so by emailing the entire committee and specifying the date of the meeting, time of the meeting, and the topic(s) to be addressed. Meetings must be so called no fewer than 2 days in advance for committees with fewer than 10 members, or 7 days in advance for committees with 10 or more members. These time limits do not apply to the LNC's Executive Committee, the LNC's Advertising and Publications Review Committee, and the Judicial Committee.
- d) Electronic meetings may be called by either:
 - The committee Chair, or
 - 1/3 of the committee members or 2 committee members, whichever is greater.

However, the call of an electronic meeting can be canceled if a majority of the committee members email a cancellation request to the entire committee prior to the scheduled time of the meeting.

- e) For electronic LNC meetings, messages calling or vetoing a meeting must be sent on the LNC-Business email list.
- f) When a sufficient number of people have issued a call for a meeting, the committee Chair or Secretary shall issue a notice of the meeting to each member and alternate of the committee. In addition to the standard notice content, the meeting notice shall describe how to participate in the meeting.

- g) Each participant must provide his own equipment and connectivity, including but not limited to any computer, internet access, web camera, microphone, earphones, or telephone. Participants have the right to participate in an electronic meeting by telephone, however they should use a computer connection if feasible so as to be able to more fully use the Adobe Connect features. The organization is not responsible for providing a central location for physical attendance of an electronic meeting. For face-to-face meetings, electronic participation is not allowed.
- h) Each participant must accurately identify himself by name when joining the meeting.
- i) Electronic meeting participants must try to eliminate, as much as possible, background noise, echoes, and call waiting interruptions. Participants shall not place their telephone connection on hold if the system has music or messages playing while in that mode.
- j) All participants legally consent to having the meetings recorded, should the committee opt to do so.
- k) Electronic meetings are special meetings such that only the topics listed in the call of the meeting may be considered during the meeting.
- For original main motions, the committee Chair or Secretary shall document the time at which the vote tally was announced. A participant with voting rights who was present during the debate of the motion but who lost his connection to the meeting may still reconnect to the meeting and cast his vote on the motion no more than 5 minutes after the announcement of the vote tally.

This report will provide information concerning efforts to build and support Libertarian campus organizations. I shall provide an updated report at the LNC meeting in New Orleans should additional information become available.

- 1) I continue to respond to inquiries from people who want information about the LP campus outreach effort. I am usually able to respond within 24 hours of receiving an inquiry, although as noted previously the standard deviation in response time increased a little this fall.
- 2) I continue to work with the Advocates for Self-Government to provide material (e.g., "Operation Politically Homeless" kits) to campus organizations. (In the interest of full disclosure, please note that I am the chairman of the Board of Directors of the Advocates.)
- 3) I continue to work with various state and local LP organizations to assist their campus outreach efforts. For example, I anticipate giving several addresses during the Spring 2015 semester sponsored by LP campus organizations.
- 4) I continue to work closely with Students For Liberty to build libertarian groups at high schools and colleges. (I am a member of the Board of Advisors of SFL.) As part of this effort, members of the SFL board and I have found ways for the LP to use the many services available from SFL. We must take care in the ways we work together to avoid jeopardizing SFL's 501c(3) status.

I am pleased to report that I gave the keynote address at the SFL regional conference in Winston-Salem, North Carolina on Nov. 1. In addition, I gave the keynote addresses at the European Students For Liberty conferences in Paris, France on Sept. 13, Madrid, Spain on Oct. 25, and Reykjavik on Nov. 15.

I am also pleased to report that once again the LP will sponsor a booth at the International Students For Liberty Conference in February. I anticipate giving an address at the conference on the "nuts and bolts" of building campus organizations.

- 5) I continue to receive invitations to speak at high schools, colleges, and universities during the school year. In addition, I am frequently asked to speak to students who are studying politics and government.
- 6) I continue to work with Young Americans for Liberty (YAL) on programs of mutual interest.
- 7) I shall work with Wes Benedict concerning ways to find and utilize more college Libertarian volunteers. In addition, I shall work with him to utilize the assistance of LPHQ interns for various campus organizing projects.

This report will provide information concerning my efforts as International Representative to assist the work of libertarian political parties and activists throughout the world. At this time, the LNC's International Representatives are Geoff Neale and I.

1) I gave keynote addresses to the European Students For Liberty conferences in Paris, France (Sept. 13), Madrid, Spain (Oct. 25), and Reykjavik, Iceland (Nov. 15). During my participation in these events, I frequently met with people associated with libertarian political organizations in those countries. I am pleased to report that my participation in these events was very well received.

Based upon the comments I received following my appearances at these events, I anticipate that I shall be invited to address several events in Europe in 2015. I have already been invited to give at least one address in Berlin, Germany next year; I suspect I shall make at least two trips to Europe next fall.

- 2) I am trying to find time to accept an invitation to visit Brazil during 2015 to assist the campus libertarian movement there. If I am able to accept the invitation, I suspect that I shall meet with several libertarian political activists during the visit.
- 3) I may have the opportunity to travel to Australia in 2015 to work with libertarian campus activists. If I am able to do so, I shall seek to meet with libertarian political activists (including members of the Liberal Democratic Party).
- 4) In a previous report I indicated that last summer I spoke to a Mexican libertarian who was involved in an effort to organize a libertarian political party in Mexico. He had expressed interest in my visiting Mexico to meet with the core group of people behind this effort. I do not know the current status of this effort; I hope to learn more about it soon.
