### CALL TO ORDER

Nick Sarwark called the meeting to order at 9:03 p.m. (all times Eastern Daylight Time).

### ATTENDANCE

Attending the meeting were:

Other participants were: Dan Reale (LPCT Chair), Roger Misbach (LPCT Vice-Chair), Christopher Thrasher (CT)

The gallery contained multiple other attendees as noted in the Attendance Roster attached hereto as Appendix A.

### PURPOSE

The meeting was called to discuss time-sensitive Connecticut ballot access issues.

## CONNECTICUT PETITION DRIVE

There was a period of question and answer with the Executive Committee and representatives from the Libertarian Party of Connecticut including Chris Thrasher and Dan Reale. Mr. Thrasher forwarded a summary report which is attached hereto as Appendix B. Items discussed included:

- Amount of raw signatures gathered
- Validity rate of signatures
- Amount of pledges of money or signatures
- Physical observations of items on petitions (handwriting, date of birth, certifications)
- Fundraising by the LPCT

Mr. Redpath moved to encumber \$10,000 of LNC funds for the statewide candidate petition drive in Connecticut.

Mr. Goldstein moved to amend so that the motion would read: Move to encumber \$10,000 of LNC funds for the subject statewide candidate petition drive in Connecticut with the proviso that said funds be released in \$2,000 increments after verification that the Libertarian Party of Connecticut has an equal amount of funds available for use in their treasury.

After debate, this amendment proceeded to a vote as follows:

- Voting aye: Goldstein, Harlos, Lark, Merced, Redpath
- Voting nay: None
- Abstaining: Sarwark

The amendment was adopted with a 5-0-1 vote total so that the motion then read: ***Move to encumber \$10,000 of LNC funds for the subject statewide candidate petition drive in Connecticut with the proviso that said funds be released in \$2,000 increments after verification that the Libertarian Party of Connecticut has an equal amount of funds available for use in their treasury.*** [180712-7]

This motion then proceeded to a vote as follows:

- Voting aye: Goldstein, Harlos, Lark, Merced, Redpath
- Voting nay: none
- Abstaining: Sarwark

The motion as amended was adopted with a 5-0-1 vote total.

## MISC. TOPICS

### ROBINSON LAWSUIT

Mr. Goldstein inquired about the status of counsel's review of the Robinson ballot access lawsuit. Mr. Sarwark will find out from Oliver Hall and report back to the LNC or the Executive Committee, as appropriate.

### OHIO UPDATE

The Libertarian Party of Ohio has been certified by the Ohio Secretary of State as a minor party, and the Republican Party has until Monday to file a challenge.

## ADJOURNMENT

The meeting adjourned without objection at 9:31 p.m.

LP CT has been collecting signatures since March. LNC was previously contacted, but no action has been taken up until this time.

The LP CT volunteer signature expected validity rate is 78%

This was based on a sample of 236 Total Signatures on 50 Sheets.

50 Signatures were randomly checked, and 39 were valid.

There are additional unaccounted for signatures currently collected. Turn-in is Sunday.

All petitioners will adhere to a strict code of conduct and abide by all Connecticut laws applicable.

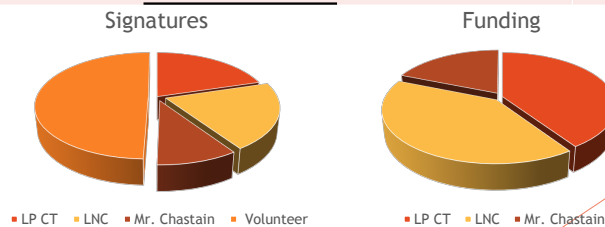
Preference will be given to Libertarian petitioners.

For some petitioners, hotels and other expenses will be provided. This is reflected in the total signature cost, and WILL NOT result in additional drive expenses.

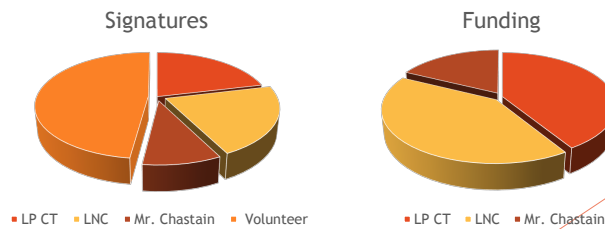
