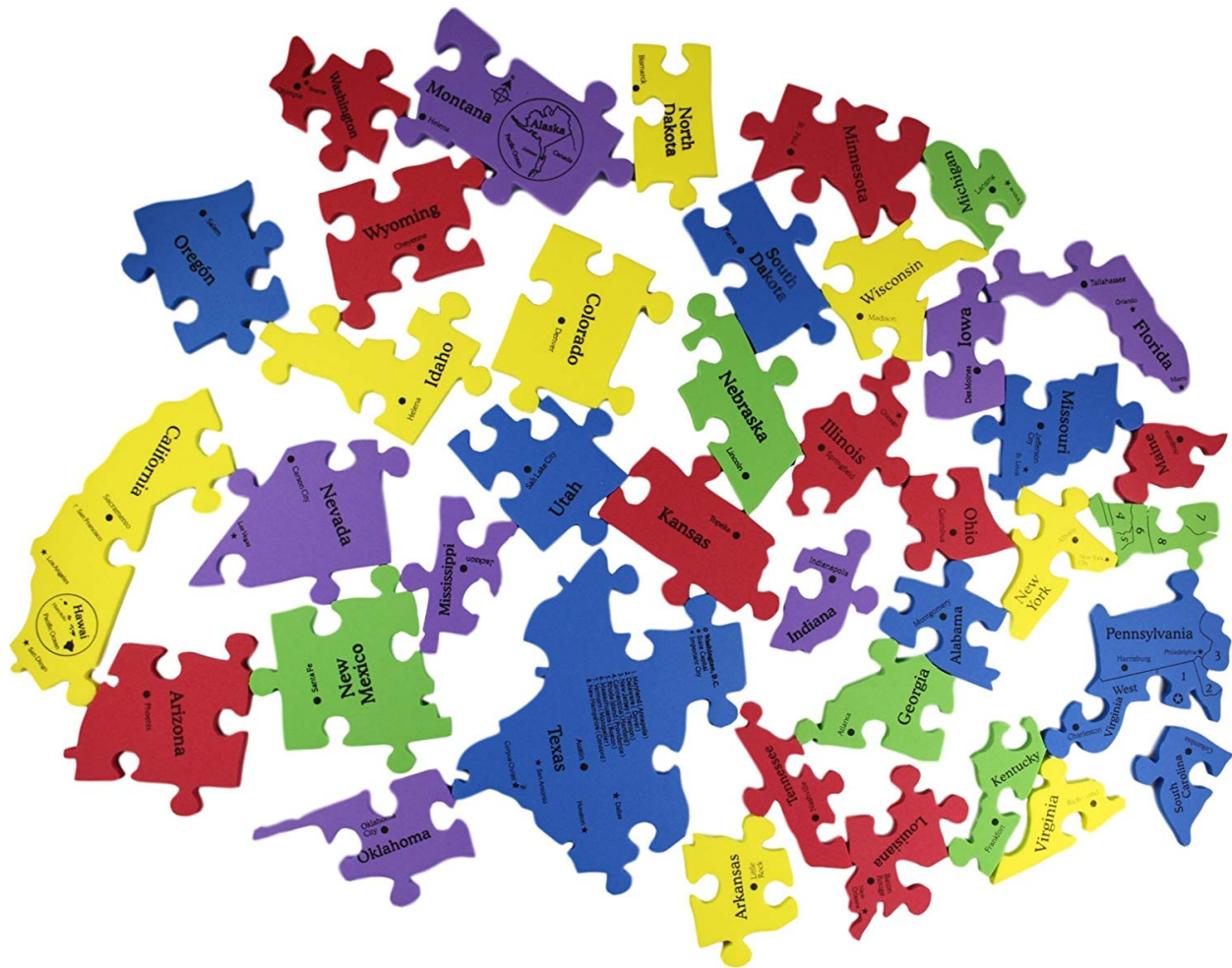

NATIONAL PARTY GOVERNANCE

The Libertarian National Committee (LNC) is composed of four (4) officers, five (5) at-large representatives, and up to ten (10) regional representatives and alternates all elected for two-year terms from national convention to national convention. This manual is focused on the formation of affiliate regions and the election of their respective representatives and alternates.

PERTINENT NATIONAL BYLAWS

ARTICLE 7: NATIONAL COMMITTEE

2. *The National Committee shall be composed of the following members:*

- a. the officers of the Party;*
- b. five members elected at large by the delegates at a Regular Convention; and*
- c. any additional members as specified below:*

Any affiliate party with 10% or more of the total national party sustaining membership within affiliate parties (as determined for delegate allocation) shall be entitled to one National Committee representative and one alternate for each 10% of national sustaining membership. Affiliate parties may, by mutual consent, band together to form "representative regions," and each such "region" with an aggregate national party sustaining membership of 10% or more shall be entitled to one National Committee representative and one alternate for each 10% of national party sustaining membership. "Representative regions" may be formed or dissolved once every two years during a period beginning 90 days before the beginning of and ending on the second day of the National Convention, and notice of new formations or dissolutions must be given in writing to the national Secretary prior to the close of the Convention at which they take place.

3. *The National Committee shall take office immediately upon the close of the Regular Convention at which they are selected, and serve until the final adjournment of the next Regular Convention.*

4. *A National Committee member shall be a sustaining member of the Party, and shall not be the candidate of any party except the Party or an affiliate.*

6. *A National Committee member who fails to attend two consecutive regular sessions of the National Committee shall be deemed to have vacated his or her seat. The appointing body shall be free to reappoint the member who vacated the seat.*

8. *A National Committee Regional Representative or Alternate may be removed and replaced only by the act of the affiliate parties that constitute the subject region. The voting procedure for the removal and replacement of regional representatives or alternates shall*

be determined by the regions. In the absence of any such procedures, a majority vote of the state chairs comprising the region shall prevail.

IMPORTANT DATES TO NOTE

The first day of the convention is May 22, 2020; thus, the first day for region formation and dissolution is February 22, 2020, and the final date is the close of business of the convention on May 23, 2020.

PERTINENT NATIONAL CONVENTION RULES

RULE 8: ELECTION OF OFFICERS AND NATIONAL COMMITTEE

4. In the event a region has not otherwise provided for the election of its National Committee representation then the delegates from the region shall elect its regional representative and alternate, provided there are at least five delegates present. Each Region's delegates may elect their representative and alternate in whatever manner they choose, provided all delegates present from that region are given equal voice in the selection.

NOTE ON REGIONAL ELECTIONS

Most regions choose to elect their representatives at a special regional caucus meeting during the national convention. Meeting space is provided for this purpose, and the Convention Oversight Committee is the point of coordination for the current regional representatives to set up these elections, if applicable. If regions are formed earlier -- i.e., during that ninety (90) period prior to the national convention -- the constituent affiliates can agree to a different method of electing their representatives as long as all delegates are given equal voting rights. The only region that opted for that route this term was Region 4 comprising California and Nevada. California is large enough to constitute a region on their own, so traditionally their regional representatives are elected at their annual state convention just prior to the national convention.

NOTE ON REGIONAL NUMBERING

There is a theoretical possibility of ten (10) regions with each having exactly ten percent (10%) each of the national membership (the bylaw defining which numbers count towards membership are discussed thoroughly in the Notice of Delegate Allocations previously sent, see Bylaws Article 4.4).

There are no hard and fast rules on the numbering scheme for the regions, i.e., which region is numbered "one," which region is numbered "two," and so on. If a majority of states in a prior region remain, they will retain the same region number. Traditionally, the region that contains Alaska is always Region 1. In the event of any uncertainty or confusion, the LNC or the LNC Secretary will set the region numbers.

ROLE OF THE REGIONAL REPRESENTATIVES AND ALTERNATES

While there is no set “job description” in the national bylaws for the regional representatives, their basic duty is to represent the interests and positions of their constituent affiliates on the LNC. The regional alternates sit in the place of their corresponding regional representatives in their absence. The alternates are entitled to debate openly on the LNC Business List giving their region potentially two (2) voices in important issues on that forum. A diligent regional representative is an asset to their affiliate states acting as a conduit between the national party and themselves and providing a focused contact person for members in that region that have questions or concerns regarding the national party. Although state affiliates can choose not to join a representative region, the positives of doing so greatly outnumber any potential negatives (including the fact that regions can only be joined or left every two (2) years). I strongly urge all states to join a region and to elect dedicated and talented representatives. I served my first term on the LNC as the regional representative for Region 1 and advocated for their interests like a tiger (so much that I still feel quite protective of them). Oftentimes, these relationships form tight bonds that last far beyond the current term. It is, however, the right of any affiliate to choose to forgo joining a region, and there are usually one or two states that are unrepresented each term either by choice or failure to timely join a region.

The regions can set their own rules and expectations for their representatives as long as these items are codified in a written regional agreement signed by the state chairs (or their authorized representatives) of each of the constituent affiliates.

WHAT IS THE PURPOSE OF FLUID RATHER THAN SET REGIONS?

There may be higher priority concerns other than mere geography, such as ideological affinity. It is difficult for a representative to effectively work for a region that is very divided on key issues.

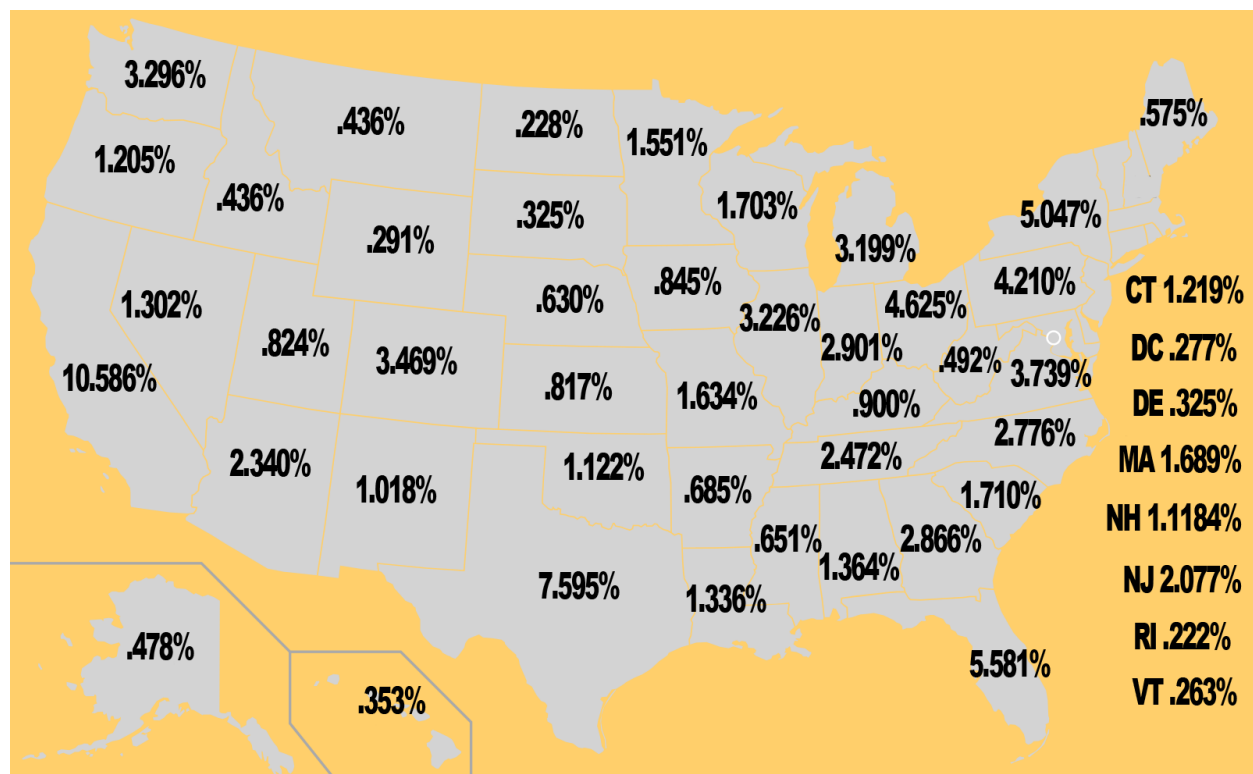

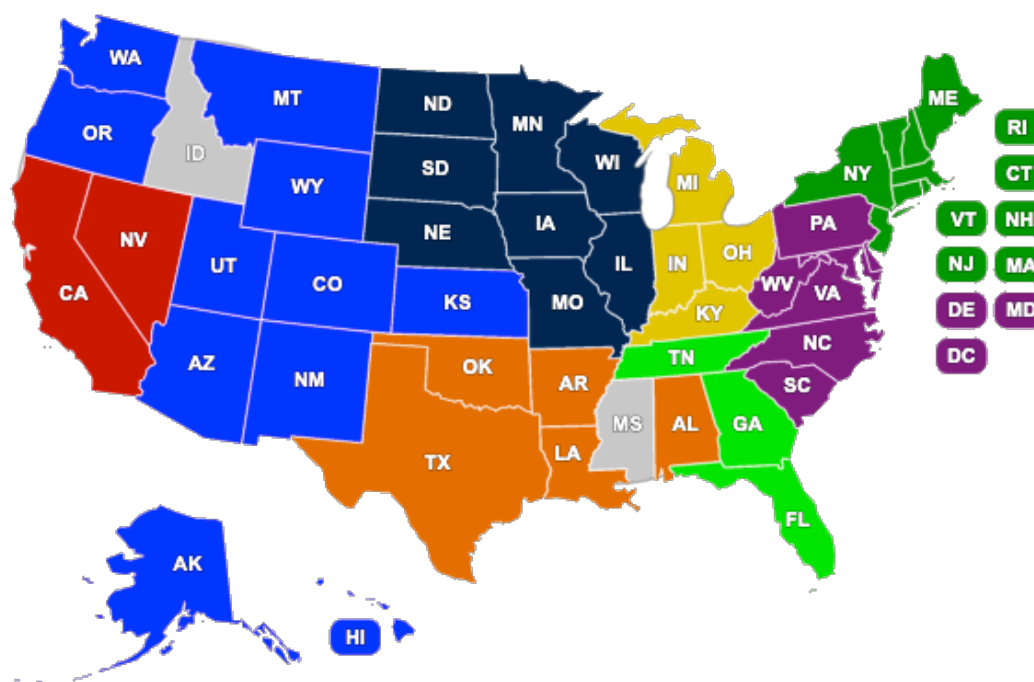


IMPORTANT NOTE ON PERCENTAGES

You may note that the percentages listed in the Delegate Allocation Manual are different from those presented here. This difference is due to the exclusion of the seventy-one (71) members listed as “other” who are not domiciled in any affiliate state and thus should not be counted for or against percentages used for regional representation.

When those seventy-one (71) members are added back in, the total figure of 14,514 BSM members is reached for the calculation of delegate allocations while 14,443 is used for regional formation.

SAMPLE REGIONAL AGREEMENTS

SAMPLE FORM A: This is a boilerplate agreement form prepared by the national party. Regions are free to use this form as is or to modify to suit their needs.

SAMPLE FORM B: This is a customized agreement form used by Region 1 during this term.

Please note that regions are free to use these forms, one of their own creation, or none at all. If there is a signed agreement, copies of the agreement signed by each constituent state chair must be filed with the LNC Secretary prior to the close of the convention. If the region decides not to use any signed agreement, the attached **Region Formation Notice** is the minimum form that must be filed with the LNC Secretary prior to the close of the convention.

Libertarian Party Region Formation Agreement

The state affiliates of the Libertarian Party listed below hereby form a representative region for the purpose of electing the number of members and alternates of the Libertarian National Committee that are allocated by the Libertarian Party bylaws to the region based on the number of national party sustaining members associated with the region.

To facilitate the gathering of signatures, signatures may appear on separate versions of this agreement. All versions together shall constitute the agreement.

A regional caucus shall be held at each regular national convention. Each registered National Convention delegate of states party to this agreement who are present at the caucus shall have one vote. If there is more than one nominee for any office, voting shall be by ballot.

This agreement shall become effective upon filing with the Secretary of the national Libertarian Party a number of versions of this agreement signed by states with enough national party sustaining members to form a representative region. After this agreement has come into effect and before nominations have been opened at the regional caucus, a state affiliate may join or withdraw from this agreement with the written consent of a majority of the other state affiliates party to this agreement if the bylaws of the national Libertarian party so permit. Once nominations have opened, a state affiliate may join or withdraw from this agreement with the written consent of all other state affiliates party to this agreement if the bylaws of the national Libertarian party so permit.

The term of office for a regional representative or alternate shall commence at the close of the convention at which a representative region may be formed and shall end at the close of the next convention at which a representative region may be formed.

Once the elections have been completed, a person elected as a regional representative member or alternate of the LNC may be removed from office by:

- 1) a vote of the region's registered national convention delegates at a regional caucus, or
2) the signature of state chairs who are both a) a majority of the state chairs in the region and b) chair states which had a majority of the national party sustaining members in the region as determined for the formation of this region.

A vacancy may be filled by:

- 1) a vote of the region's registered national convention delegates at a regional caucus, or
- 2) a majority of the state chairs in the region without regard to the number of sustaining members in each state.

The Libertarian Party of the state of _____ agrees, in accordance with the terms above to enter into a representative region with the Libertarian Parties of the states of _____, _____, _____, _____, _____, _____, _____, and _____.

2018 REGIONAL AGREEMENT FOR REGION ONE

The state affiliates of the Libertarian Party listed below, through their state chairs, hereby form a representative region for the purpose of electing the number of members and alternates of the Libertarian National Committee that are allocated by the national Bylaws to the region based on the number of national party sustaining members associated with the region. To facilitate the gathering of signatures, signatures may appear on separate versions of this agreement. All versions together shall constitute the agreement.

A regional caucus shall be held at each regular national convention. Each registered National Convention delegate of states who are signatory to this agreement who are present at the caucus shall have one vote. Voting shall be by ballot using approval voting, and None of the Above (“NOTA”) will always be an option in at least the first round and until eliminated. A candidate must receive at least a majority to be elected. If no candidate receives a majority after three ballots containing the same candidates, or if NOTA receives the first majority, the position in question will remain vacant until next convention. The current LNC representatives (or in the absence of such representatives, the regional state chairs) will be responsible for organizing the regional caucus and balloting and will make an effort to provide reasonable notice to the affected delegates.

This agreement shall become effective upon filing with the Secretary of the national Libertarian Party a number of versions of this agreement signed by state chairs with enough national party sustaining members to form a representative region. After this agreement has come into effect and before the final vote has been called on the election of the regional representatives at the regional caucus, a state affiliate may join or withdraw from this agreement with the consent of a majority of the other signatory state affiliates.

The term of office for a regional representative or alternate shall commence at the close of the convention at which a representative region may be formed and shall end at the close of the next convention at which a representative region may be formed.

Once the elections have been completed, any person elected as a regional representative member or alternate of the LNC may be removed from office by:

- 1) a majority written vote of the region's registered national convention delegates who were present and qualified to vote at the initial election, or
- 2) a majority vote of the state chairs in the region.

A vacancy may be filled by:

- 1) a majority written vote of the region's registered national convention delegates who were present and qualified to vote at the initial election, or
- 2) a majority vote of the state chairs in the region.

2018 REGIONAL AGREEMENT FOR REGION ONE

DUTIES AND EXPECTATIONS FOR REGIONAL REPRESENTATIVES

The elected representatives will sign off on this agreement indicating their agreement with these duties and expectations:

- 1) diligently represent and advocate for the interests of the regional states in their votes, debate, and participation in the business of the Libertarian National Committee;
- 2) make a good faith effort to confer with each of the state chairs prior to votes of significant import;
- 3) provide regular updates to regional members (i.e. website, social media groups, electronic newsletter, regional conference calls);
- 4) pass on any regional contact information obtained to the successor representatives;
- 5) provide both a telephone number and email address for members to contact the representatives and be reasonably available to speak with same;
- 6) make a good faith effort to confer with each of the regional chairs prior to the production of a regional report for submission to the Libertarian National Committee;
- 7) timely produce and submit comprehensive reports to the Libertarian National Committee;
- 8) make a good faith effort to attend at least one convention in each of the regional states per term;
- 9) the regional alternate is expected to fully participate in all proceedings, including attendance at LNC meetings, and to assist the Regional Representative as needed, including a regular report of their activities to be included in the regional report(s).

The representatives will not be guaranteed any compensation for travel in relation to their duties though any regional state may voluntarily contribute towards a travel expense fund.

The Libertarian Party of the state of _____ agrees, in accordance with the terms above to enter into a representative region with the Libertarian Parties of the states of **Alaska (0.637%); Arizona (2.199%); Colorado (3.309%); Hawaii (0.384%); Kansas (0.932%); Montana (0.582%); Oregon (1.144%); New Mexico (0.945%); Utah (0.664%); Washington (3.274%); and Wyoming (0.219%)**

2018 REGIONAL AGREEMENT FOR REGION ONE
