

Q1 How will you be credentialed at the LP National Convention?



Q3 How likely are you attend an online convention in late May or early June?






Q5 How likely are you to attend an in-person convention if remote participation is available?






Q6 Do you believe that the LNC has the authority to call an online convention under the LP Bylaws, Roberts Rules, and emergency considerations?




Q7 Do you believe that the delegates at an in-person convention would ratify the decisions of an online convention after-the-fact?
